



**ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 64**


- **Good afternoon, America! I am Roy Merritt and I am running as a candidate for President of the U. S. A. in 2024**
- **As I indicated in my last speech (Campaign Speech # 63), the War of Second Secession has begun. Depending on how the war rolls out, it could eventually turn into and be called the Great War II, or it could also be referred to as the Second Civil War, except that the two sides are much too un-civil to each other to call it that**
- **The War of Second Secession may have actually begun many years ago—decades or even centuries ago**
- **If war is to happen, it should begin here in southern New Mexico**
- **There do not seem to be many deterrents to war that are developing, but rather many inducements**
- **Hispanic Democratic Party terrorists and traitors produce many new spurs and incitements to war daily**
- **Aggressions in the “war”—the War of Second Secession—go on and on, and on, and on— day after day, week after week, month after month, year after year**
- **There cannot be and will not be a surrender or capitulation happening from either side**
- **Since my renewed involvement in the “war,” beginning early in 2020, there has been much destruction and devastation mainly occurring on my four-plus acre property here in Doña Ana County of south-central New Mexico just outside of Las Cruces. As such, based on the repeated acts of terrorism by the**

terrorists and traitors, and the resulting damages to property and structures, there are already many existent “war” monuments resulting from the War of Second Secession. These “monuments” can be seen in plain sight in many locales and spot locations when driving up and down Dripping Springs (or Dripping Trash) Road

- It should be noted though that there are many losses other than in physical structures that have already occurred as well in the War of Second Secession
- As I have stated before, the State of New Mexico cannot continue to exist with essentially 50% good people and 50% bad people. The bad citizens—the dissidents, revolutionaries, terrorists, traitors, saboteurs, torturers, and *coup d’ étatists*—predominate in positions of power and authority in the State. Normal American citizens cannot live here in the State of New Mexico in peace, contentment and happiness
- The Hispanic terrorists and traitors began to take over the State gradually as the Democratic Party sold out the American nation with its’ open-doors’ policy for illegal immigrants, invaders, insurgents, and infiltrators coming into the country from Mexico and the southern Americas many decades ago
- Based on this history and these occurrences, most current politicians, whether Democrats or Republicans, do not have the seriousness or the resolve to fix the problems of New Mexico that they created with their policies. Thus, they will need to get serious if they are to fix the problems and issues that are inherent and can easily be seen and witnessed in the State
- And, while our American leaders are reaching this state of seriousness, American society and civilization as we know it, and have known it in the past, will continue to deteriorate
- Historically speaking, the allures of U. S. wealth has drawn Hispanics northward from Mexico and the countries of Central America and South America.

- Hispanics and Anglos represent two completely different peoples that occupy two essentially different societies in one country. It is much like having two countries or two nations in one. Because of this, the U. S. A. has become two nations under God rather than one
 - Hispanics and Anglos are not “brothers” and “sisters,” but estranged acquaintances
 - Hispanics and Anglos agree on almost nothing. The two ethnicities or “peoples” have little to nothing in common
 - Hate is strong on both sides
 - The principles of Anglos and Hispanics are completely different
 - The peoples of these two different heritages—ethnicities—cannot seemingly coexist in the same State, in the same country, on the same continent, on the same planet
 - Anglos generally put little to no emphasis on the same things that Hispanics consider as important to life and living. Firstly, most Americans, because of love of country, could not even contemplate immigrating to another country just for a little extra income. And, we would not continue to have innumerable children as liabilities that we could not support on our own
 - The political and philosophical differences and disagreements are huge
 - The differences in ethics, morals and values between the two ethnicities are great and difficult to resolve
 - The differences between Anglos and Hispanics are largely beyond repair or fixing. And, the differences that exist are not acceptable as is to either side, and there does not appear to be solutions that are easily negotiable


- 
- Anglo citizens in New Mexico cannot, and should not, have to live in tyranny and subjugation without their Constitutional freedoms, rights and protections, and also without law and order
 - It must be said, though, that there are some good, loyal and patriotic Hispanic citizens. And, there are some common physical “likes” but they are not generally things of importance
 - A Hispanicized America, that would be much like the State of New Mexico now, is not negotiable or acceptable
 - A bilingual nation, with half the country speaking English and the other half Spanish is not going to work for a unified and integrated nation. It would help if the U. S. government made the Spanish language null and void as a language of inter-citizen communication in the U. S. A. Additionally, all bilingual programs and bilingual education should be ended in universities immediately
 - After the State of New Mexico is kicked out of the Union of American States, terrorist universities like NMSTU and UNM should be shut down during the period of expulsion, and reconfigured with newly adjusted curricular programs during this period before they are, or can be, approved for reopening as American State universities
 - In addition, these universities should abolish all programs, departments, instruction and teaching of treason, terrorism, torture, revolution, rebellion, insurrection, insurgency, and *coup d’ étatism*
 - Universities are one of the most important “cogs” in creating the dire circumstances and the dilemma that our nation finds itself in today
 - Universities are stewards of a nation’s Constitution and laws that must be enforced equally for all citizens of the country. There cannot be “special” or “privileged” people who are treated differently and above others

- Most everyone in communities surrounding universities have connections with them in one or more ways. Universities provide education and training in many areas to local citizens, and also students from around the State, as well as some national and international students. Universities also typically operate a number of community-college branches throughout the counties in which they are located and also sometimes even regionally. The education and training that they provide affect all students equally. Some students of the total population should not be given advantages and/or disadvantages because of the educational programs that universities offer and provide
 - In addition to language programs, universities generally train and educate students in a variety of professional programs and curricular areas too numerous to mention all of them. However, they include doctors and physicians, nurses, medical practitioners, and health care workers; lawyers, of course, law enforcement and police academies; teacher education programs training future high school, middle school and elementary teachers, principals and administrators; all types of business, social and government-worker programs for public servants and managers; industrial arts and trades; all of the sports and athletic programs, and sports medicine; and all of the academic disciplines
 - All of these educational programs affect the types of professional workers that are employed and work in our towns, cities, counties and States. All of the messages, both overt and covert, that students receive from curricula during their educational programs determine the types of individuals that we have not only in our workplaces but also in our societies and communities
 - Many messages that students receive as part of their educations and curricula, are oftentimes hidden and not necessarily good for nations, societies, communities and their citizens. Students can be indoctrinated with the political ideas of their teachers, instructors and professors. And, this is what I have been trying to get to in my speech today. That is, universities may, intentionally or unintentionally, produce radicals, dissidents, revolutionaries,

traitors, *coup d' étatists*, and all sorts of other undesirables that ultimately are not good for integrated societies and productive citizens

- Thus, we have to accept, I believe, that some universities are producing individuals out of their programs that they may not even necessarily have planned to. And so, universities can be mixtures of the good and the bad
- As early as 1520, Martin Luther (1483-1546), German monk and Protestant religious reformer, stated: "I greatly fear that universities—are wide gateways to hell."
- And, believe it or not, some rather despicable people have had some fairly reasonable statements, on the surface, about universities. One particular quote, originally attributed to Adolf Hitler (1889-1945), the Austrian-born German Nazi dictator, believe it or not, states: "The universities are filled with students rebelling and rioting. Communists are seeking to destroy our country...The republic is in danger...from within and from without. We need law and order...Without law and order our nation cannot survive..."
- Some other pertinent quotes about universities, emanating from a speech by another unlikely source, are those of Spiro Theodore Agnew (1918-96), Vice President of the United States (1969-73) under Richard M. Nixon. Of course, Agnew later resigned amid charges of illegal financial dealings during his governorship of Maryland (1966-68)

In any event, Agnew stated in 1970: "The political and social demands that dissidents are making of the universities do not flow from sound basic educational criteria, but from strategic considerations on how to radicalize the student body..." In rules to help universities, he states that there should be no amnesty for lawlessness or violence. He also adds that we must look to how we are raising our children." Furthermore, he also questioned whether universities that receive America's children are prepared to deal with the challenges of the nondemocratic Left."

- And so, universities may not be the bastions of all things good. (Thomas) Woodrow Wilson (1856-1924), 28th President of the U. S. A. (1913-21), educator and author, stated: “The great voice of America does not come from the seats of learning, but...comes to us from the homes of the common man...”
 - As you know, I have proposed that some universities, like one of my own—NMSU or NMSTU—may need to be shut down during the period of expulsion of the State of New Mexico from the Union of American States. I do think that the university is somewhat, if not largely, responsible for the current predicament that we face with Democratic Party Hispanic terrorists and traitors here in the State. When I began my program at the university in 1990, there were definitely some dissident, revolutionary, rebellious, and *coup d’ étatist* philosophies being espoused by misguided graduate students that were never abrogated or refuted by professors or other students in classes I took at the university
 - I have said before that those in leadership positions among the Democratic Party Hispanics, many of them likely academics related to the university perhaps brought me back to the area as an alumnus to support their cause, or at least to possibly provide cover for their revolution, silent secession, subliminal war, and planned eventual *coup d’ état* of the American government. The university had previously donned the mantle of an academic doctoral degree on me some 30 years prior. And so, maybe they thought that if the area and its attributes were acceptable to me, then perhaps they might or could very well be made acceptable to others, or perhaps all
 - Of course, if the university did serve, and has served, as an important “cog” in the State of New Mexico’s revolution and silent secession from the Union of American States, and all of the terrorism, treason, sabotage, torture, and other high crimes and misdemeanors we are experiencing, and have experienced over the past several decades here in the State, then it must accept sanction and punishment like all of the other parties involved
 - I have recommended that we hang at least some Democratic Party Hispanic terrorists found guilty of committing acts of domestic terrorism. Perhaps a top

cabal of university officials, if directly involved in the “grand conspiracy” to overthrow the U. S. government could also possibly receive the ultimate sanction of the death penalty

- **Along with all of the other penalties and punishments of County, State and federal officials, all of the campus police of New Mexico State Terrorist University could also be fired from their positions, at the very least**
- **I have also recommended:**
 - (1) Firing all Las Cruces city police and law enforcement;**
 - (2) Fire all law enforcement personnel in the State of New Mexico;**
 - (3) Hang the heads of all law enforcement agencies in the State;**
 - (4) Hang the terrorist Sheriffs of counties, such as those of Doña Ana County, New Mexico since the beginning of 2020;**
 - (5) Do away with Doña Ana County as a political unit;**
 - (6) Shut down the Doña Ana County (DAC) office building and fire all DAC employees**
 - (7) Hang all Doña Ana County officials in certain leadership positions (e.g., permitting enforcement)**
 - (8) Hang leaders of the terror camp or enclave called “Terror Valley,” including all subdivision leaders and officers**
 - (9) Hang the Governor, Lt. Governor (if existent) and Attorney General of the State of New Mexico;**
 - (10) Hang President Traitor Joe Biden, the Vice President, and the Attorney General at the Federal level**
