- I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024


- I'd like to say "hello" to the States of the U. S. A. where I have lived and worked over my lifetime, and to the people and citizens of these States:

 - Hello twice to New Mexico, my current State of residence, where my spouse and I lived previously from 1988-96, and again from 2020-present


- America today has lost its way and is NOT following the nation's founding ideals and principles and those of its Founding Fathers—members of the American Constitutional Convention of 1787

- George Washington, America's first President and the "Founder of our Country" aided in molding together into units the diverse elements that formed the U. S. A.

- Benjamin Franklin was the eldest and wisest of America's Founding Fathers. He was a member of the Continental Congress, a drafter of the Declaration of Independence along with Thomas Jefferson, and helped to establish our new government

- The U. S. A. was founded to be different than other nations in the world and to be exceptional. It was founded on the ideals of individuality and that citizens were to have the guaranteed freedoms, rights and protections of the Constitution and Bill of Rights

- People generally from other parts of the world know nothing and care little about what the U. S. A. is or was supposed to be about. It certainly is NOT about them, and it wasn't founded specifically for them
 - The U. S. A. was not meant to cater to large ethnic groups of people. If they came here, there were obligated to adapt to the nation
 - The country strayed far off course when we started allowing large ethnic population groups to invade the nation
 - The Democratic Party was largely responsible for America losing its way and straying off course. The Democratic Party today has no principles! It has lost its' original ideals of democracy promulgated by Thomas Jefferson and about which the party was founded
 - The Republican and Conservative parties follow the U. S. Constitution, the Bill of Rights and the rule of law and order. Alexander Hamilton, another of America's Founding Fathers, was the ideological founder and original leader of the Republican Party in the U. S. A.
 - Government entities at all levels—federal, State, County, city and local—in the U. S. A. now are lost and have strayed far off course
 - Here in the southwestern U. S. A., the State of New Mexico, Doña Ana County, the city of Las Cruces, New Mexico State University, and local subdivisions like "Terror Valley" are certainly lost and are way off track
 - Government units like Doña Ana County, New Mexico, cannot exist in the U. S. A.
 - No government units of the U. S. A. can repeatedly carry out vendettas of crimes, vandalism and terrorism against their own citizens
 - The State of New Mexico cannot exist in the U. S. A.
 - The State of New Mexico is overseeing, harboring and protecting the actions of all the counties in the State, including Doña Ana County

- Because of this, the State of New Mexico must stand good on all the damages and harm—both physical and psychological—suffered by its citizens, including my spouse and myself, and to our lives and property
 - The federal government oversees the actions of all the States of the Union, and as such, in this case, must stand good for the damages and harm resulting from the actions of the State of New Mexico, Doña Ana County, the city of Las Cruces, New Mexico State University, and local government units and subdivisions
 - None of these government units are living under the Constitution of the U. S. A., and are not implementing and enforcing the laws of federal and State governments
 - All of these government units additionally must stand good for damages and harm inflicted on citizens of the U. S. A. by actions directly and indirectly caused by other citizens like Hispanics who have illegally entered and invaded the U. S. A.
 - Thus, government units at all levels—federal, State of New Mexico, Doña Ana County, the city of Las Cruces, New Mexico State University, and local governments and subdivisions—are responsible for not protecting citizens like my wife and myself from the terroristic, vandalistic and other criminal acts committed by other local citizens, primarily Hispanics and some, though perhaps NOT ALL, members of the Democratic Party
 - Similarly, citizens like those locally in Las Cruces, Doña Ana County, and in the State of New Mexico who are carrying out these terroristic, vandalistic, and criminal acts, and have done so over the past 3+ years against my wife and myself, cannot exist or be in the U. S. A.
 - These people cannot be here, and, at the very least, must be removed—expatriated—from the U. S. A.
 - Any Democratic Hispanic or other citizens, including professionals and working members of the trades, doing terrorism, vandalism, and other criminal acts against other citizens must suffer the consequences and punishments for their actions, including imprisonment, expatriation, or in extreme cases, the ultimate sanction—the death penalty

- Generally speaking, many of the local people here cannot theoretically live or be in the U. S. A. However, they could very well be citizens of Mexico if they wanted and Mexico would accept them. The State of New Mexico, itself, or any parts thereof, could very well be absorbed back into Mexico. Many local citizens would fit better and be happier as citizens of Mexico
- Alternatively, the State of New Mexico, or parts thereof, that do not fit and cannot be part of the U. S. A., could form their own separate country here in the Southwest—a new country separating Mexico from the U. S. A., perhaps called “MEXAMER” or “AMERIMEX”
- Radical steps such as the aforementioned might prevent removing New Mexico from the Union of American States, Civil War, expulsion or expatriation of many of the Hispanic citizens of New Mexico to another territory or place to live in the world
- At this very critical state in the history of the U. S. A., some radical actions must be taken to save the U. S. A., which is deteriorating rapidly as a nation
- As I have stated before, a malignant cancer is now metastasizing—growing and spreading—across the country and is a threat to the U. S. A., and as such, a threat to the world and to our planet—Earth
- This cancer must be excised in one way or another in order to save our nation
- The State of New Mexico, Doña Ana County, Las Cruces, New Mexico State University, local government units, Democratic Party and Hispanic citizens are clear and present dangers to the U. S. A., the world and our planet
- The current federal government is also a threat to the continued existence of the U. S. A., and a revolutionary overthrow or *coup d' état* of the American government could very well happen at any time that could very well spell the end of our nation, our democracy, our republic, the U. S. Constitution, the Bill of Rights, the Declaration of Independence, and of all of our freedoms, rights and protections guaranteed by our Founding Fathers and our founding documents
