


ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 38

- I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024
- I have essentially been forced to run for the presidency in order to try to protect myself
- I am running against my current home State and State of residence—New Mexico, my County, my city, my former university—NMSU, where I received my doctorate from in 1994
- I'm running against the Democratic Party, which in my view, is on the pathway to destroying our nation by not enforcing the U. S. Constitution and the rule of law and order, and seemingly seeking the overthrow of our government
- I'm running against most of the people of my community, as there is almost nothing going on in our community that is allowed by the U. S. Constitution and the laws of our country
- I'm running against my family's wishes
- There is obviously no one who wants me doing what I am doing
- Since returning to the State of New Mexico in 2020 for my retirement, almost every aspect of my life has been destroyed—totally devastated
- I have received no help, assistance or support from anyone, either personally or in my campaign for the presidency
- So far, my campaign website, <https://www.merrittforpresident.org> has been censored and I have been forced NOT to go on the campaign trail because of events and circumstances here in New Mexico and on our property

- As I have stated before, it is me against the world, and I don't necessarily understand all of the reasons why that is so or needs to be the case
- I have been fighting terrorism and local terrorists for over three years. I have since defined over 20 new forms of terrorism that they have been using against our family and our property
- There are criminals, vandals and terrorists running amok in our community
- I have had every crime, vandalistic act and act of terror committed against me and our property here in Las Cruces, County of Doña Ana, New Mexico
- I am aggravated, harassed, intimidated, hounded and persecuted by these people on a daily basis
- I have had threats levied against me from all quarters, including from a few members of my own family
- I should say, though, that as far as I know, that all of these evil people are Democrats and terrorists
- Here, in Doña Ana County, New Mexico, there is no law enforcement or police presence. There is no longer any protect and defend. It appears that police and law enforcement, including the Sheriff of Doña Ana County, are actually working in concert and partnership with criminals, vandals and terrorists
- I know that the County of Doña Ana has been at war against my spouse and myself since we moved back to this area. They destroyed two large areas of our property before we even moved into our newly constructed home here. This destruction has required over three years of intensive labor on my part in order to try to fix problems which they created. It appears that they are doing their best to destroy our property by facilitating flash flooding and committing other acts against our property of a destructive and retributive nature
- There are also broad and active forces that are acting and working against my health and welfare

- Over the past few years, I have had repeated health episodes of multiple hours in which I feel terrible, and I typically rebound to normal good health within a matter of hours. I have related these to drug episodes, or something toxic or poisonous in my system, presumably from something in my environment—food, water, air, prescription medicine, OTC medicine, or something similar
 - Today, again, for example, I have been sick for hours and have no idea what is wrong with me, and I have no way of determining that. However, based on past episodes like this that I have experienced, I may well be back to my normal self and in relatively good health for my age in hours—and that, in itself, is very suspect
 - I have been unable to get even marginally acceptable health care, even with medical insurance, here, since my return to the State of New Mexico
 - Because of this and other reasons related to my retirement here after 30 years away, especially those aforementioned, I would recommend to the world and to the people of the U. S. A. that no one should ever consider retiring here again
 - It is obviously a very difficult and perilous situation that we find ourselves in here in New Mexico
 - Because of our vulnerability, I am asking all of the other States of the country to watch over us to the degree possible, and see that nothing untoward happens to us
 - I have previously asked for help from multiple sources at the State and Federal levels (now of course in Democratic hands), but have received none to date. All of our troubles essentially began when the Biden administration assumed office in January 2020, and we returned to New Mexico in February 2020
 - However, if there is help that can be afforded behind the scenes by agencies or departments of the federal government, I and my family would be very appreciative
