

**ROY D. MERRITT FOR U. S. PRESIDENT**  
**CAMPAIGN SPEECH # 43**

- Hello, I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024
- In one of my prior campaign speeches, number 33, I stated my belief that large ethnic groups of people should remain in situ in the countries where they were born for the foreseeable future
- I can understand that people want a better life for themselves and their children, and want to immigrate to countries like the U. S. A. where they feel they have the best chance to do so
- However, because the U. S. A. as a nation has been weakening steadily and inexorably for many years because of our immigration policies, especially of the Democratic Party's open-doors policy, and basically large invasions of people from Mexico and the central and southern American countries, I believe that we must make major changes in the policies immediately and posthaste
- As a good-will gesture, we should take a few people from those countries of the world where people would like the chance to immigrate to the U. S. A.
- However, we must stop the mass immigration of citizens of different ethnic groups into the U. S. A., NOW
- Currently, in New Mexico, and perhaps one or more other States of the U. S. A., we are essentially in a civil war between Hispanics and Anglo citizens because of the manner in which Hispanics have not integrated willingly, gratefully and peaceably into American society
- Their widespread refusal to adopt the English language has essentially resulted in two nations living apart and fighting a constant battle of attrition in the State of New Mexico

• Many, if not most, immigrants have now turned against the U. S. A. and its citizenry, and are now committing terroristic, treasonous and *coup d' é tatist* acts against the nation and its pre-existing people

• My wife and I have been dramatically affected by these terroristic, criminalistic and vandalistic acts perpetrated against us and our property over the last three-plus years

• Something must be done to fix this situation and circumstance

• Among the options that need to be considered are:


- (1) The expatriation of large numbers of Hispanics who have immigrated primarily illegally into the U. S. A. over the past quarter-century or more;
- (2) Removing large groups of Hispanics to one or more islands in the far Pacific Ocean, presumably U. S. territories, to live out the remainder of their lives. I am primarily speaking here of people who are incapable of living peaceably in the U. S. A., and are seemingly incapable of adapting to U. S. life, laws, and the U. S. Constitution;
- (3) Sentencing ring-leading terrorists and traitors to the U. S. A. to the ultimate sanction—the death penalty; this would presumably also include government officials who are deserving of such a sentence;
- (4) Withdrawing New Mexico, and any other State of the U. S. A. like New Mexico temporarily or permanently from the Union of American States;
- (5) Conducting a forced elimination of the current exigency by military action up to and including if necessary a limited civil war to correct these problems


• The already existent damages and harm to U. S. citizens like my wife and myself due to actions of the U. S. government under Traitor Joe Biden and his Vice President since entering the office of presidency cannot be measured. We are still suffering tremendously as a result of prior government policies, especially those of the Democratic Party


• The time has come now in the U. S. A. to give priority to pre-existing American citizens and their families. We can still continue to aid the world and other countries

as we are able to, but we must stop the hemorrhaging, deterioration and destruction of the U. S. A.

- We cannot continue to have terrorists and traitors running amok in our American communities, towns, cities, Counties and States
- Here in Las Cruces and Doña Ana County, New Mexico, I suspect that most everyone I've had close contact or involvement with on a personal or professional basis are terrorists and are using and implementing terrorism tactics against me
- This would include professional people in all walks of life
- Since I have returned to this area, I have been appalled at the poor state of health care and medical services in the city, County and State
- Because of the manner in which my health and medical treatments have been implemented, or NOT, I now believe that most, if not all, the medical professionals that have been involved in my treatment are terrorists
- I have thought from the beginning that many of these individuals have not been following, and are not consonant with, the Hippocratic Oath which all medical professionals are sworn to uphold
- It constantly amazes me how low some people can get in the name of monetary and personal gain
- My health visits to hospitals, doctor's offices, etc., have been deteriorating, along with my overall health, since I returned here to New Mexico in early 2020 for my retirement
- A few doctors, including medical specialists, have refused to treat me and have summarily released me as a patient, even at my strong objection
- I have had several very bad interventions in local hospitals, and have previously accused some medical practitioners of using terroristic tactics, including "torture" and "torturous acts" in treating me

- These acts include withholding, delaying, or not implementing medically therapeutic treatments needed, at least within a timely manner
  - I believe that all of these acts are either based in economics or politics or both
  - I have been unable for the most part to get therapeutic medical treatments and medicines here in Las Cruces and Doña Ana County, New Mexico
  - I know that when I was here some 30 years ago, I had to move my medical treatments to El Paso, Texas in order to get good—medically therapeutic—care
  - As of today, I am recommending to the nation, the world, and whoever wins the next presidency, that they aggressively go after many of the medical personnel in the State of New Mexico
  - I would at this time also nominate many of these people for “first call” in implementing the death penalty against terrorists and traitors of the city, County and State
  - And, if my health care status deteriorates further, I would ask the American people, especially those in other States of our nation, to read between the proverbial “tea leaves,” so to speak, and determine exactly what happened and what should be done in reprisal
  - I know that I have never witnessed, or even heard about anything like this before in my life. I would never have thought anything like this could occur in the U. S. A.
  - But, then again, I have already told the nation that our country is in deep, deep trouble at the present time
  - And now, when you have many of our citizens at war with others, and doing terroristic and traitorous acts against them, then it is time to fight back with everything in our nation’s arsenal

- I have previously indicated that I wanted to hang thousands, if not millions, of people—terrorists, traitors, and just plain evil people—on the first day of my administration
  - Such hangings could be re-instituted and occur on either the White House grounds or at the National Mall on newly constructed gallows in Washington, D. C.
  - Many people laugh and scoff at my brazenness, even or especially as a presidential candidate, but something has to be done
  - Matters have deteriorated considerably since I first put forward these proposals
  - Terroristic and traitorous or treasonous acts have only intensified and worsened
  - And so, I put forward the prospect again before the American people and the electorate
  - Because of the current state of our nation, I believe that no penalty or punishment should be ruled out for persons guilty of these offenses
  - No punishment or penalty is unreasonable for individuals guilty of the crimes I have outlined
  - However, for the American people to be assured that these matters will be addressed in all due seriousness, I now believe that they will most likely have to elect me as their next president
  - I am the person running for the presidency most intimately knowledgeable of the tactics and strategies being used by these largely Democratic operatives—terrorists and traitors—including many Hispanics
  - As today is Thanksgiving Eve, and this speech represents my Thanksgiving campaign address, I want to make a few comments related to this special holiday and occasion in my concluding remarks
  - My father passed away on Thanksgiving Day in 1983 at 76 years of age

- Naturally, Thanksgiving Day, though not necessarily Thanksgiving, has never been the same to me
  - My mother passed in December 1992 at the age of 83
  - After your parents die, you tend to lose a lot of solidity and grounding in life
  - The act of Thanksgiving though still holds great meaning for me
  - Regardless of all of its problems, difficulties and concerns, I would say that America is still the greatest country in the world and as an IDEAL
  - The U. S. A., though, has been tarnished and sullied through many decades of seemingly uncontrollable and indiscriminate immigration of hordes of people with poor, if not evil, intentions
  - Our country is now overfilled with bad people and is amok in lowlifes, deadbeats, criminals, vandals, terrorists, traitors, counter-revolutionaries and *coup d' é tatists*
  - I feel that we will be fortunate if we can save and preserve our nation, so that it can go forward into the future strong, confident and resilient so as to live long and prosper
  - I believe it is God's desire that America, or at least the concept of "America"—YES, our "America!"—persist until eternity
  - America represents God's best work in a mundane, worldly and Earthly sense. America is not heaven and it never will be, but it remains the best that Earth has to offer
  - We all should feel blessed and be thankful that it continues to endure on this Thanksgiving Eve—November 22, 2023
