

**ROY D. MERRITT FOR U. S. PRESIDENT  
CAMPAIGN SPEECH # 66**

- Good morning, America! I am Roy Merritt and I am running as a candidate for President of the U. S. A. in 2024
- This is Campaign Speech # 66
- Nothing that goes on here in “Terror Valley,” Las Cruces, Doña Ana County, and the State of New Mexico is Constitutionally and lawfully allowed in the United States of America
- Of course, because people have been illegally invading the State *en masse* for many, many decades and were not stopped, they mistakenly got the impression that they could do anything in the U. S. A. and it would be permitted and accepted
- First, you only have to look at the non-enforcement of the laws of the U. S. A. to know that something is wrong and amiss in the State
- People in general seem not to understand that the U. S. A. lives under the Constitution which dictates specifically what is lawful and acceptable, and the primary and most important requirement is LAW AND ORDER
- There is no law and order that can be observed or experienced by the people of “Terror Valley,” Las Cruces, Doña Ana County and across the State of New Mexico
- This is why I have said that at a minimum all of the policemen and law enforcers in the State MUST be fired, AND, because this has not been due to ineptness as much as treason, the leaders of law enforcement should either be given the ultimate sanction and the death penalty, or should be permanently exiled, expelled and expatriated from the U. S. A.

- Thus, as a result of the non-enforcement of U. S. laws and the failure of the State to live under the U. S. Constitution and to protect people's Constitutionally guaranteed rights and freedoms, the State should officially lose its Statehood status and be moved back to new territorial status (NTS) for a minimum period of 10 years, or until it is fully capable of implementing all of the requirements and obligations of Statehood
- And, if the State loses its Statehood, then the two major State universities should lose their status as universities and higher-level educational institutions in the American system
- I have previously stated that these two universities are as much responsible for the current existent conditions of lawlessness, chaos, anarchy, and revolution in the State as is law enforcement and government leadership
- I have attended both universities—UNM in 1988-90 and NMSU from 1990-94—and I believe that they have been miseducating and misteaching students possibly since their founding. They have misconceived their roles as universities in the AMERICAN system of higher education. Administrators have been misinformed and misguided in their oversight of educational programs in these two higher-educational institutions. As such, they miscommunicated and misdirected professors and educators to implement curricula, instruction, training and degree programs that were mistaken from the outset. And so, it is no wonder that the products—students—of these educational institutions came out of these universities miseducated and mis-trained for their future lives and livelihoods in the U. S. A. Aspects of both the overt and hidden curricula led many students to exit these institutions as rebels, revolutionaries, insurrectionists, traitors and *coup d' étatists* to the U. S. A. Students came, and continue to come, out perhaps fully educated and trained for life in Mexico and other countries of origin in the Central and Southern Americas, but not for highly successful, productive, fulfilling, peaceful and law-abiding lives in the U. S. A. The misconduct and misbehavior of many young adults and professional people here in the local area provide ample testament and proof of their miseducations and mis-trainings at New Mexico State University, for example

- So, to summarize to this point, three very important and crucial factors in the State of New Mexico's *fait accompli* silent secession from the Union of American States has been the State's treasonous government leaders AND police and law enforcement AND university educators and trainers
- And, as relates to the State's silent secession, it must be understood that States of the U. S. A. cannot willingly and purposely withdraw from the Union of American States. The North's Union victory in the American Civil War firmly established the precedent that States could not legally secede from the Union of States
- The Civil War thus resolved that there is NO right of a state to unilaterally secede on its own. A State may not otherwise secede except "through revolution," AND, as here in the State of New Mexico, that extreme option will most likely be met with a new War of Secession or Second Civil War
- The American Union of States is a Perpetual Union that is a feature of the Articles of Confederation and Perpetual Union (1778) which established the U. S. A. as a political entity. However, the Union itself predates the U. S. Constitution and was formed by the Articles of Association of 1774, and was further matured and continued in the Declaration of Independence of 1776
- When a territory has a sufficient population and makes its' desire for statehood known to the federal government, Congress generally passes a so-called Enabling Act authorizing the people of that territory to frame a proposed State constitution as a step toward admission to the Union. The Enabling Act of 1906 authorized residents of the New Mexico territory to form a state government and to gain admission to the Union
- A State's admission to the Union is provided by the Admissions Clause of the U. S. Constitution in Article IV, Section 3, Clause 1, which states:

**New States may be admitted by the Congress into this Union; but no new State shall be formed or erected within the jurisdiction of any**

other State, nor any State be formed by the junction of two or more States, or parts of States, without the consent of the Legislatures of the States concerned, as well as the Congress


- Clause 2 of Section 3 goes on to state:

The Congress shall have power to dispose of and make all rules and regulations respecting the territory or other property belonging to the United States

- Section 4 of Article IV guarantees a republican form of government in each State, and that each State is to be protected. It further iterates:

The United States shall guarantee to every State in this Union a republican form of government, and shall protect each of them against invasion; and, on application of the Legislature, or of the Executive...against domestic violence [underlining added for emphasis]

- Thus, the Constitution guarantees the rights of individual States, oversees the disposition of territories, protects States from invasion (supposedly like that from Mexico and the Central and Southern Americas) and domestic violence like the domestic terrorism that we are experiencing here in the State of New Mexico
- The territory that is now New Mexico did not become a U. S. State until 1912. The New Mexico territory was in existence more than 50 years before it was granted statehood status by Congress
- New Mexico appears to be on a track and trek of revolution that would possibly and arguably permit it to eventually secede officially from the American Union of States. The path seems to be buttressed over the long-term recent past by “silent” and “subliminal” actions of State government leaders, Statewide law enforcement, and of the two higher-level educational institutions in the State

- Presently, a “silent” or “subliminal” War of Second Secession is underway in the State and likely began several decades ago. The only question remaining is whether this Second Secession and “war” will be met with a full-fledged second Civil War as it did during the Southern States’ first secession that led to America’s initial Civil War, or War Between the States, from 1861-65
  - However, the current acts of revolution, rebellion, sedition, treason, terrorism, torture, sabotage, chaos, anarchy and lawlessness would seem to argue against a peaceable parting of the ways and more toward a violent resolution with a second great conflagration or civil war
