ROY D. MERRITT FOR U. S. PRESIDENT CAMPAIGN SPEECH # 58

 Good morning, my fellow Americans. I am Roy Merritt and I am running as a candidate for President of the U. S. A. in 2024

• This is Campaign Speech # 58

• In my platform and speeches, I have failed to concentrate my attention on the high crime of treason and traitorous activities nearly enough

• By general definition, treason refers to the betraying, and betrayal of, one's country, and includes aiding and abetting an enemy of one's country; participating in a conspiracy against one's country, such as in a prospective *coup* d' état; rebellion; revolt; revolution; sedition; subversion; insurrection; insurgence; mutiny; treachery; perfidy; disloyalty; and apostasy

• The opposite of treason is patriotism and love of country, flag, its' pre-existing citizens, adherence to law and order, living under its' Constitution, and loyalty, faithfulness and fidelity to one's country and everything about it, including its' official language and other attributes

• Treason is also one area where Hispanic citizens differ from, and have differed from, current and past citizens of the U.S.A., and other ethnic-group émigrés of our country

• Hispanics are by general definition essentially treasonous to the U.S.A. before they enter the country; for example:

- (1)Believing that the country should accept them whether it wants to or not;
- (2) Entering the country under false pretenses;
- (3) Having negative attitudes about pre-existing citizens of the U.S.A.;

- (4) Breaking the laws of the country when entering illegally;
- (5)Coming into the country primarily for economic reasons, and NOT for love of country;
- (6)Not agreeing with and being consonant with the basic tenets and attributes of the country;
- (7) Not intending to integrate with pre-existing citizens;
- (8) Planning and wanting to live the way you want, principally as you did in your prior country;
- (9)Not believing that your country—the U. S. A.—has a legal, moral, and ethical right to control its borders, to ferret you out, and expel you from the country for entering illegally, and feeling that you have a right to force yourself on the U. S. A. and its pre-existing citizens;
- (10) Thinking that you are better people than the people of the U.S.A.;
- (11) Having no intention of learning, adopting and speaking the official language of the country—English;
- (12) Planning on doing whatever you have to do—by "hook or crook" to earn a living in your new country;
- (13) Having no consuming interest in living under the Constitution and the laws of your country, particularly those you disagree with

• The U. S. Constitution deals with treason, treasonous and traitorous activities in several Articles and Sections

• Section 9 of Article I states that:

"No title of nobility shall be granted by the United States. And no person holding any office of profit or trust under them shall, without the consent of the Congress, accept of any present, emolument, office, or title of any kind whatever from any king, prince, or foreign state." •Section 4 of Article II states:

"The President, Vice-President, and all civil offices of the United States shall be removed from office on impeachment for and conviction of treason, bribery, or other high crimes and misdemeanors."

• Section 7 of Article III states:

"(1) Treason against the United States shall consist only in *levying war* against them, or in adhering to their enemies, giving them aid and comfort. No person shall be convicted of treason unless on the testimony of two witnesses to the same event, act, or on confession in open court.

(2) The Congress shall have power to declare the punishment of treason, but no attainder of treason shall work corruption of blood or forfeiture except during the life of the person attained."

• Section 2 of Article IV states:

"A person charged in any State with treason, felony, or other crime, who shall flee from justice, and be found in another State, shall on demand of the Executive authority of the State from which he fled, be delivered up, to be removed to the State having jurisdiction of the crime."

• Treason, with regard to immigrants, especially those who have entered the country illegally, and under false pretenses, should be defined by law differently and more broadly, so as to have grounds on which to punish those guilty of the crime by expatriation, death penalty in extreme cases, or other means judged appropriate to the circumstances and seriousness of the crimes committed

• Among those acts which should be used in defining treason, and grounds for expulsion, expatriation, and death should be the following:

- (1)NOT loving your country and being loyal and faithful to it;
- (2)NOT obeying its laws;
- (3)NOT supporting its Constitution;
- (4) NOT respecting its flag;
- (5)NOT defending it against all enemies;
- (6) Aiding and abetting an enemy of your country;
- (7) Waging war against your country and its pre-existing citizens;
- (8) Participating in a conspiracy against your country, such as in a planned *coup d' état*;
- (9)Committing any of the following acts, or especially multiple acts of this class:
 - a. Sedition
 - **b.** Subversion
 - c. Rebellion
 - d. Revolt
 - e. Revolution
 - f. Insurrection
 - g. Insurgence
 - h. Mutiny
 - i. Treachery
 - j. Perfidy
 - k. Disloyalty
 - I. Apostasy
