




ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 60

- Good afternoon, my fellow Americans. I am Roy Merritt and I am running as a candidate for President of the U. S. A. in 2024
- I welcome all of you—the people of all 50 States to my “NOT ALL DEMOCRATS ARE TERRORISTS” campaign of the “Desert Fox” and “The Last American Patriot”
- This is Campaign Speech # 60

- Yesterday, during the presentation of my Campaign Speech # 59, my home office came under chemical attack from terrorist forces or law enforcement—both of which are the same here in the State of New Mexico—and also from a gunshot that rang out audibly during the recording of my speech a little later in the presentation
 - Both of these events—the chemical attack and the gunshot—temporarily interrupted my speech. The chemical attack caused me a severe coughing bout, great discomfort and the loss of my voice for about five minutes
 - The gunshot was obviously intended to shut down my speech that I was delivering
 - I have suffered with these chemical attacks several times previously as I was either delivering earlier speeches or working outside my home here in “Terror Valley,” New Mexico. The past chemical attacks also made me extremely ill on several occasions for periods up to half-a-day
 - As you know, my spouse and I reside directly across the road from a major terrorist camp or enclave located here in “Terror Valley”
 - I believe that we now have domestic terrorist camps or enclaves like this not only across the State of New Mexico, but also across the broad expanse of the U. S. A. These terrorist camps are a major focus of my campaign, and I am advocating that these camps be destroyed and put out of existence, and the terrorists either hung by the neck until they are dead or be expatriated to “Devil’s Island” and “Survivor Island,” U. S. territories far out on the western Pacific Ocean
 - Domestic terrorism is running rampant as a new “black scourge” threatening to destroy the U. S. A.

- Additionally, I believe that an overthrow, usurpation, or *coup d' état* of the U. S. government, although an imminent possibility, is NOT an option for our nation
 - America's democracy and republic are in deep trouble today, and we may very well not be able to maintain and keep them into the future
 - As one of my recent poems says, "America is on fire burning!"
 - Our neighborhoods and communities are filled with terrorists, traitors, saboteurs, torturers, vandals, criminals, infidels and all types of vermin, most of whom are of the Democratic Party
 - And, while these events are occurring—as America burns—the 4th Estate—the U. S. and world news media—are twiddling its' or their proverbial thumbs and quibbling its' or their mouths
 - These problems and exigencies must be met and attacked head-on as they will not fix themselves. And it would be best to face these troubles now, so as to hopefully avoid any prospect of a new great war—Civil War II—in our nation
 - I am a Conservative and I believe strongly that we must continue to live under the U. S. Constitution and the rule of law and order
 - I am also pleading with the American electorate not to get locked into voting for the lesser of two evils in 2024
 - We must do everything within our power not to have a fraudulent national election in 2024
 - It is up to Americans to continue to work toward a more perfect Union of States—a renewed and vibrant democracy and republic—for greater justice and domestic tranquility, and to seek robust provisions for our common defense and
