

ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 31

[I want the people of the U. S. A. and the world to know that this speech was illegally monitored in preparation, and was repeatedly saved to a secondary site by some governmental or other entity who owes me and my spouse millions, if not billions, of dollars for usurping my U. S. Constitutionally guaranteed rights, freedoms and protections in doing so.]

- I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024

- The reasons cited in the Preamble to the U. S. Constitution for establishing it are:

- (1) To form a more perfect union;
- (2) To establish justice;
- (3) To insure domestic tranquility;
- (4) To promote the general welfare; and
- (5) To secure the blessings of liberty


- As I stated in my Campaign Speech # 4, I have not found any of these for myself in my second stay here in the State of New Mexico.

“There is no unity; there is no justice; there is no tranquility; there is no protection or defense; and there certainly is no LIBERTY, or the blessings thereof.”

- New Mexico has placed limits on our amount of freedom, and infringed on our rights as American citizens

- The Bill of Rights, contained in the first ten amendments to the U. S. Constitution guarantee every American citizen freedoms that are ABSOLUTE, and that cannot be abridged or denied

- The City, County, and State governments have denied the free exercise of my religion as I desire to practice it. They have abridged and placed restrictions on my freedom of speech, or as incorporated therein I believe, free expression and the practice thereof, and also on my free press and publication rights, including my right to publish my ideas without constraints or inhibitions in the “town square”

- I have not found the freedom to express my patriotism or love of country, and this rights, as I practice it, also involves my freedom of religion
 - There are many general citizens and local officials in the various governmental units if the State of New Mexico (the County of Doña Ana, the city of Las Cruces, and community subdivisions) who do not understand the rights, freedoms and protections guaranteed in the U. S. Constitution
 - The County of Doña Ana, New Mexico, where we live, has instituted regulations that go against the individual rights guaranteed by the U. S. Constitution
 - The State of New Mexico has denied my spouse and I the equal protection of the law
 - And, whether they recognize and know it or not, governments cannot deny individual citizens their rights, freedoms and protections guaranteed by the U. S. Constitution
 - States and other governments cannot choose whether they want to live under the U. S. Constitution or not
 - The U. S. Constitution is not an option for our nation, the States and local governments
 - We cannot VOTE “yeah” or “nay” on whether to live under the Constitution in the U. S. A.
 - Neither can States and other government entities choose whether to enforce the laws of the U. S. A, and whether to establish *order* (disciplined behavior) in society
 - The County of Doña Ana, New Mexico is a government bureaucracy out-of-control that is over-regulating, attacking and punishing people for not doing anything wrong
 - Law enforcement appears to not only NOT be enforcing the laws, but appears in many cases to be fostering, facilitating and expediting law-breaking by gangs of young hoodlums
 - County government workers also seem to be facilitating, expediting and forcing local citizens to do criminal acts against free citizens of the U. S. A.

- Many of the citizens, especially Hispanics, of the community, City and County where we live have been engaged in open rebellion and insurrection against the U. S. A. and the U. S. Constitution
- Discrimination by Hispanics against Anglo citizens is prevalent
- There appears to be at least an *ex facto* union of criminal workers that is employing scamming and extortion to exact as much income as feasible from Anglo citizens for their services and repairs
- As many of these acts and practices cannot lawfully exist in the U. S. A., the State of New Mexico, itself, theoretically speaking, cannot exist in the U. S. A.
- And, neither can any other State of our Union exist as New Mexico is
- All 50 States of the U. S. A. live under the U. S. Constitution and the Bill of Rights
- Exactly when New Mexico first strayed from the U. S. Constitution is not known by me
- However, during my doctoral program at NMSU in the early 1990s, it was clear to me that there were many Hispanics with ideas, that on the surface, were revolutionary, seditious and traitorous to the U. S. government and the U. S. Constitution
- It appears that New Mexico now has a majority Hispanic population, and does have a Hispanic Governor, and also other State and Doña Ana County government officials in charge of, and responsible for, running the State and the County
- The Democratic Party, theoretically, at least on paper, also cannot exist as currently constituted and operating in the U. S. A.
- The party has been supporting an open-doors immigration policy with Mexico and the southern Americas for decades
- The party long ago determined that every new immigrant who came into the U. S. A. from these regions, and oftentimes from elsewhere on the globe, was most likely a new voter for the party
- This began the revolutionary, seditionist stray path off-track for the Democratic Party

- Former president, Ronald Reagan, and many other politicians have noted for decades that the Democratic Party was “so far Left that it had left the country”
- The question in my mind now is, did it dawn on members of the party then, that they were not only in essence, but also in practicality, leaving the U. S. A. and the U. S. Constitution behind in supporting such a revolutionary, seditious pathway that they were on
- Undoubtedly, the fervor for strengthening the voting prowess of the party likely overwhelmed all other inner voices and advisory thoughts concerning this new pathway for the Democratic Party
- However, it is clearly evident that at least for the last half-dozen or so, Democratic presidents, and other high-level Democratic Party leaders, all supported increasing the Hispanic minority population numbers as high as possible to gain new voters and an overwhelming edge in voting margins over the Republican Party and their leaders and leading candidates
- Perhaps it was unclear whether, when Hispanic candidates won elections for local, State, and eventually national offices, they would continue to direct the country down a similar U. S. Constitution-adhering pathway as prior leaders of both major political parties had done
- The next question arising now, in my mind, is whether New Mexico’s Hispanic governor now is the first ruling Hispanic governor to win office in any State of the union
- Also, if that be the case, is the way in which this Hispanic governor, and possibly any other Hispanic governor, rules and runs the office of governorship that different from governors of Anglo and other ethnicities would and did rule, with or without understanding that they were not following the dictates of the U. S. Constitution, and perhaps not implementing law and order, in a manner consistent with how governors in the past had run their offices
- In any case, it appears that this governor of New Mexico is clearly taking the State and its people down a pathway that is not consistent with the founding ideas and principles of the U. S. government and the U. S. Constitution, and not consonant with a strong law-and-order implementation policy

• I know that since my return to New Mexico in 2020, I have stated many times that I was not living in the U. S. A. and did not feel like I was. It felt like, and was, a different State and nation I was living in, than that in all the other 8 or 9 States I lived in, and the times of my life that I lived in them

• New Mexico was much different. It seemed to be a more lawless, chaotic and anarchic society, and in, many ways an “uncivilized” society


• There was not a clear mandate of law and order emanating from the top leadership of the State

• Here in New Mexico, it certainly did not seem that my U. S. Constitutionally guaranteed rights, freedoms, and protections were of any concern to those ruling over the State, and also were of no concern to fellow citizens and to people in general

• Regardless, New Mexico now appears to have arrived at a place where it is no longer part of the U. S. A., and apparently also most citizens, especially the Hispanics of New Mexico, don’t care whether we are living under the U. S. Constitution or not; have no concerns seemingly for their rights, freedoms and protections; don’t appear to have the same need or desire for law and order, and for a disciplined, law-abiding society as that in which I am used to living, and have lived in all of the other States where I have resided during my lifetime

• My overall conclusions, though, after living in the State of New Mexico and the County of Doña Ana over the past three-plus years are:

- (1) We are not living here under the U. S. Constitution
- (2) The Constitutional rights, freedoms and protections guaranteed thereunder, are being denied to citizens
- (3) Law and order is not being implemented and adhered to
- (4) Criminals, vandals and terrorists are running amok in the State of New Mexico, County of Doña Ana, and City of Las Cruces
- (5) The State of New Mexico appears to have left the Union of American States, whether it is recognized or not
- (6) The Democratic Party, and perhaps most of the citizenry of the State, County and City are unconcerned and are outwardly supportive of the current state of affairs

- (7) It will take a strong reversal of current policies to get the State of New Mexico moving on the right track again
 - (8) It will most likely require, in my view, removing the State of New Mexico, at least temporarily, perhaps for a period of years, from the Union of other American States
 - (9) It may also require major changes in the leadership of the Democratic Party in the State and nationwide to move to a pathway consonant with the U. S. Constitution again; and also in the attitudes and minds of the people and the general citizens, at least of the State
 - (10) The State of New Mexico is now, and perhaps has been for decades, likely knowingly, on a revolutionist, seditionist pathway that would lead it to a *coup d' é tatist* U. S. governmental- and U. S. Constitutional- overthrow posture that seems to be existent and evident at the present time
 - (11) The Democratic Party has either knowingly, or questionably, unwittingly been leading the State of New Mexico down the current anti-Constitutional, anti- law-and-order pathway that we find ourselves on now
 - (12) This pathway has led the State to the current chaotic, anarchic conditions with rampant crime, vandalism, and terrorism present in the State
 - (13) Law enforcement in the State is apparently supportive of the current pathway the State, County, and City governments are on, or are on a wait-and-see posture to determine if leadership and government directives will change or alter with new governors, county and city leaders, or not
 - (14) It may be difficult for these citizens in the minority in the State, and those harmed by the current pathway the State is on, to receive any type of recompense or damages caused by the current pathway and party leadership positions and ruling decisions made over recent years
 - (15) The Democratic Party will be reluctant to recognize that it has been on a revolutionist, seditionist, anti-U. S. Constitution, anti- law-and-order, terroristic and *coup d' é tatist*, government-usurping pathway for decades, and that the party's positions and postures are not consonant with the ideals and principles of the nation's founders and of the U. S. A. as a leading democratic and republic state in the world

- In any event, welcome all of you Democrats to today's *new*, revamped, "revitalized" and totally illegitimate Democratic Party—the Party of Terrorism, Anarchy and Revolutionary U. S. Government and U. S. Constitution Overthrow
