

ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 49

- Hello, I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024

- I'd like to again say "hello" to the people—good American citizens—of the States of the U. S. A. where I have lived and worked for years each during my lifetime: MN, WY, AK, NY, TX, KY, IN, WV, NH & NM twice (1988-96; and 2020-present)

- I'd also like to give you and all of the American people an update on conditions on the ground here in the "war zone" of southern New Mexico. As its latest machination, the County of Doña Ana has torn up the only road into "Terror Valley"—the secondary road that runs for over 1,000 feet in front of our property and house. This section of the road is currently ripped up, torn asunder, and may not be blacktopped or resurfaced for some time, making it highly problematic for my spouse and myself to get out of our house, or to leave "Terror Valley" to shop or do errands. It was a perfectly good road before they began this new construction, and the people of the area have no idea why this project got off the ground when so many other local roads are in worse condition and in need of repairs much more than this one.

However, this is par for the course. Most everything done here is based on politics and is carried out in a terroristic manner—even road repairs! (Of course, this really can't happen in America.) Road construction scheduled from Thanksgiving through Christmas! And talk about dust! I don't think it's legal to fill the air we have to breathe with clouds of dust and not carry out periodic dust remediation efforts to mitigate health risks, harm and damages to persons and property

- I went out [yesterday morning] to do a bit of shopping for essentials. I was fine health-wise until I returned and came into our house and garage. Then, I became suddenly ill and stayed that way for approximately two hours. I felt like I was in

a serious condition. Afterward, I felt very good and back to my normal healthful condition. I believe that I suffered yet another attack on me by the local “infidels” and “vermin” (the latter, Donald Trump’s word) of “Terror Valley.” Those responsible are Democratic Party Hispanic terrorists and traitors in an obvious attempt to prevent my speech [this speech, Campaign Speech #49, yesterday]. - **Historically speaking, the U. S. A. has never had another ethnic group of people enter the country in the manner and under the conditions that Hispanics have**

- **Firstly, Mexico borders on and abuts the U. S. A., and groups of people could and did enter *en masse* illegally—unwanted and undesirable**


- **Mexico has no interest or intent to ever interfere with its citizens—largely, the poorest least skilled, most criminal, and least desirable—departing Mexico and entering the U. S. A. in hordes and droves. Of course, some of these “unwanted” also emanated from the Southern American countries**

- **These migrations were immediately beneficial for Mexico as a nation, principally as a “release valve,” but were hugely problematic and detrimental to and for the U. S. A. from the beginning**


- **The multiple invasions of hordes of Hispanics into the U. S. A. should have been stopped at the beginning and prevented from happening at all cost**


- **It was an unprecedented dereliction in duty, not only by America’s top leaders, including past presidents and Congressional leaders, but were also such for America’s military branches, which had never previously left the nation completely unprotected and vulnerable ever in the history of the country**

- Also, not only should these migrations have been stopped at all cost from the start, but also all, or as many of these people as possible, should have been rounded up and removed from the country to some alternative location by force
- In addition, a system should have been set up to identify authentic, pre-existing American citizens so that the invaders could have been identified and removed from the country
- Hispanics resultantly continued over the decades of the 20th century to come into the U. S. A. and essentially move about freely, unhindered and unmolested, and left to their own “devices”
- Now, today this history is coming back to haunt the U. S. A. and threatens to completely destroy our nation
- By the end of the 20th century, largely as a result of these influxes, civilization plateaued and stalled primarily in the U. S. A., but also in many, if not all, nations worldwide
- What is happening in New Mexico today is moving directionally north, northeast and east across our country to all States, and threatens to have a “domino effect” in decimating the entire nation as New Mexico has been decimated
- Per what I am now going to term the “Merritt Doctrine,” the Hispanic invasion of America, like the silent coup of New Mexico, threatens our existence, and in lieu of no other reasonable plan, must be addressed one State at a time beginning with New Mexico
- As I have said many times before during this campaign, New Mexico is “lost” and “gone” to the U. S. A. at the present time
- New Mexico is the poorest, most useless, and undesirable State in the Union of American States

- Other than for a little bit of scenery, I can see absolutely nothing positive for the U. S. A. about New Mexico
 - What has happened historically to the State cannot be allowed to happen to any other State of our Union if we can prevent it
 - First, New Mexico has to be removed from the Union of States. A silent coup d' état has already occurred and so it will be, or is, a fait accompli anyway. It has already left us—our nation—in all practicality
 - As many undesirable citizens as possible—terrorists, traitors, dissidents, revolutionaries, *coup d' étatists*, criminals, vandals, panhandlers, and just plain evil people—must be expatriated from the country. A simple statement of the Merritt Doctrine is: *if you shouldn't be here in the U. S. A., you can't be here in the U. S. A., PERIOD!*
 - Ringleaders and those who resist removal and expatriation must be made eligible for the ultimate sanction—death by hanging or by some other appropriate means
 - A period of years, perhaps up to a decade, must be taken in order to try to “fix” the State of New Mexico before it is ever allowed to rejoin the American Union of States
 - Many actions must be taken within the State of New Mexico in order to put it in the road to recovery
 - All current and past leaders (if living) of the State—governors and other high officials—must be reviewed and evaluated to determine appropriate punishments, whether death, expatriation, or other sentence
 - All current law enforcement in the State must be fired and replaced with individuals loyal to the laws, Constitution, government and President of the U. S. A.

- Counties, such as Doña Ana, must be made “defunct,” renamed and replaced because of its history as a governmental unit disloyal and unpatriotic to the U. S. A. All current County leaders should be made eligible for death or expatriation
- The two major higher-level educational institutions, NMSU (or what I refer to as, NMSTU), and UNM, must be shut down for an indeterminate period, and if re-established after the period of New Territorial Status (NTS, for short)—must be reconstituted, renamed, and possibly or potentially be relocated
- No new similar student populace can be established as currently exists in these two universities, which are not now, and never have been, consonant with U. S. interests or reflective of the U. S. people
- All current, existing revolutionary, terrorist, treasonous and coup d’ étatist enclaves and camps—like “Terror Valley”—in the State of New Mexico must be located and destroyed, and all those traitorous to the U. S. A. expatriated, and/or given death sentences as necessary. The safest way to destroy these terrorist enclaves, in my estimation, would be by bombing them out of existence, once individuals have been given the opportunity to vacate. Terror squads or paramilitary units, must go throughout the State to make all terrorist camps and enclaves “non-threats” any longer to the U. S. A., and all “undesirables” processed and removed
- All of the political philosophies or “dogmas” that led to the current state of affairs in our country must be de-legitimized, including political correctness, multilingualism and multiculturalism, bilingualism and biculturalism, “non-illegalism,” and moral equivalence or inequivalence (as applicable), et cetera
- Temporary governors and leaders of the new territory of New Mexico must be, or should be, named by Congress to rule the State during the interim period of NTS—New Territorial Status
- The territory or non-State” of New Mexico should be made ineligible to vote in national elections during the period of NTS

- Peace and harmony must be mandated and forced by civil actions in the State by national guard, or other appropriate military or para-military units, during the period of NTS
 - The Spanish language, as a language of inter-citizen communication in the U. S. A., will and must be made null and void. As with any of the many other world languages, individuals can study, learn, know, and utilize Spanish as one of the many sub-languages, existent in the country as needed, BUT officially used ONLY for effective international communication
 - No other world languages can be placed on par with English as the national language of the U. S. A., and hence, if allowed, be permitted to factionalize and split asunder the U. S. A.
 - No additional large influxes of Hispanics into the U. S. A. can be permitted during the historical period of NTS, AND for the foreseeable future, all large ethnic groups of people, should remain "*in situ*," that is, in their countries of origin
 - The history that created the current dilemma with the State of New Mexico can never be repeated with any other State in our nation
 - Those smaller groups of citizens immigrating to the U. S. A. from countries worldwide must be made to be highly "integrated" and "integrative" from the beginning of the introduction to, and association with, the U. S. A.
 - No new people can be permitted to immigrate to the U. S. A. who do not have a "spirit of integration," with pre-existing and current citizens of the U. S. A.
 - All people who wish to voluntarily leave the U. S. A. must be aided in their departures and removals from the country
 - No people will be allowed to "profit" from their prior history of non-integration and disloyalty to the country, government, and Constitution of the U. S. A.



- No other ethnic group will ever be given preferences, special treatments and benefits over pre-existing American citizens, especially the many nationwide who are still affected by poverty and the inability to raise themselves upward economically to be competitive with other citizens, including almost all of Appalachia and areas of the South. I know that my own family and myself have been greatly affected by and debilitated in some respects, especially by preferences in education and hiring practices, including affirmative action and reverse discrimination, by the aforementioned policies. I was unable to ultimately have an academic career, despite the equivalent of two doctorates, two Masters, and two baccalaureates, and exemplary qualifications due to unfair and immoral hiring preferences in higher education given to Hispanics, foreign students, and other minorities, and reverse discrimination

- From now forward, all Americans will be looked on and considered as completely “equal” without regard to any possible discriminative factors

- The U. S. A. will “step-back” to “move forward” in the sense of forcing dependence on the U. S. Constitution and the laws of the U. S. A. to determine “rightness” and “right-fit” for our nation

- After the period of NTS for New Mexico, and possibly one, two or more other States, the U. S. A.—our country—will make a new beginning—a fresh start—on the pathway to “right trackism” under a new re-validation of the U. S. Constitution and the original American Revolution and Declaration of Independence of 1776

- No new counter-revolutionary movement will be allowed in the future to move the nation off its central and main course, and mission

- The U. S. A. cannot be and will never become “two nations under God.” The U. S. A. must *forever* remain “one nation under God”
