


**ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 29**

- **I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024**
- **My spouse and I returned here in early 2020 to retire to Las Cruces, Doña Ana County, New Mexico to live in peace, contentment and happiness for the remainder of our lives**
- **Our lives began to be turned upside down gradually through 2020 until January, 2021 when they began to be completely destroyed**
- **We have had every crime imaginable inflicted on us and our property since that time primarily through the auspices of an over-reaching and terroristic County government—Doña Ana—totally out of control**
- **Our guaranteed U. S. Constitutional rights, freedoms and protections have been denied every step along the way**
- **There is no enforcement of law and order**
- **The community, city and County are chaotic and anarchic**
- **We are not free and we are not happy by any stretch of the imagination**
- **Today, I am asking the appropriate agencies of the federal government to investigate why my wife and I have been treated the way we have over the past three-plus years**
- **I believe that my life and privacy have been unlawfully invaded in every way possible**

- **I have been threatened by almost everyone, including some members of my own family who are all Democrats, by the way**
- **I am terrorized, and have been fighting multiple forms of terrorism and terroristic acts for all of this time**
- **There has been no aid provided by State and federal governments for our plight**
- **I have been fighting this terrorism and evil by all lawful means at my disposal**

- I believe that all our electronic and telecommunication equipment have been hacked and are being monitored and controlled illegally by someone or someones
 - I believe that my privacy has been invaded by illegal eavesdropping and wiretapping equipment
 - I believe that law enforcement and police believe that I am the problem, and they have been rousting, harassing and intimidating me in multiple ways and on various occasions
 - I am an outcast in my own country, and that is only because I want to live free, have my Constitutional rights protected, and not have every type of crime, vandalism and terrorism inflicted on my wife and me by local criminals, vandals and terrorists
 - I do not believe that I have done anything wrong. I have not trespassed on anyone's property, whereas it seems that the whole community feels they have the right to trespass on our property at will, and do whatever damage and destruction they want to do at any time
 - This is NOT right!
 - This is NOT Constitutional!
 - This is NOT living free!
 - This is NOT moral, ethical or legal!
 - This is NOT America!
 - My spouse and I have suffered irreparable harm and damages, both to ourselves and our property
 - The people responsible for destroying our lives need to be punished in the harshest ways possible
 - If this punishment includes expatriation, life-time imprisonment, or a death sentence to ringleaders, I am comfortable with that
 - Because we have been failed by all levels of government in the U. S. A., we believe that all levels of government should take responsibility, and see that we are fully recompensed to the degree possible for the destruction of our lives
