


ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 30

- I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024
- The State of New Mexico is currently in a state of war with the U.S. A. and the U. S. Constitution. I know not whether any other State is currently at war with the U. S. A. and the U. S. Constitution
- New Mexico should be considered a war zone by all other American States and by the American people
- New Mexico should be removed from the Union of American States immediately
- The State of New Mexico should be punished by losing all federal funding and all other allowable benefits accruing to it as a State of the U. S. A. in good standing
- Travel to the State should be curtailed and limited to that which is essential
- My spouse and I are enemy combatants now isolated and alone in the war zone. We have been abandoned and left unprotected and vulnerable by federal, State and County governments
- We have been at war here in New Mexico with our own governments for over three years
- Because the current U. S. government has not protected my wife and I from Democratic Hispanic terrorists in New Mexico, its leaders should be considered, and are, war criminals, traitors and terrorists themselves
- All war criminals, traitors and ring-leading terrorists to the U. S. A. should be sentenced to death
- The Democratic Party is at war with the U. S. government and has now made itself null and void, and "defunct" as a political party. It has not protected and defended the U. S. Constitution, and has not enforced law and order in the U. S. A.
- The names of Democratic Party candidates for federal offices, such as for President and Vice President, in the 2024 election, should be removed from all State ballots as illegitimate
- Democrats should NOT be considered as viable candidates at this time, at least for federal offices
- Many, if not most, Hispanics were enemies, traitors and terrorists to the U. S. A. on their initial entries into the country, and are still at war with their own country and countrymen
- All Hispanic businesses or commercial enterprises discriminating against Anglo citizens and not providing professionally competent services should be closed down

immediately and lose their licenses to operate in the U. S. A. The owners of those businesses and enterprises and their family members should be expatriated from the U. S. A.

- All Hispanic professionals who have mistreated, maltreated, or refused to provide services to Anglos should also lose their licenses to operate. My wife and I have had all types of professionals refuse to provide competent professional services to us
- Because of existent conditions in the war zone here in the State of New Mexico, and the continuing belligerent acts of terrorism on our property, I will be unable to go on the road immediately to campaign for the office of the presidency of the U. S. A.

- Obviously, all Americans should begin to weigh all candidates for the office of presidency very, very carefully. Some candidates have more merit than others, pun intended or not
- There is the possibility, and now the probability that any winning Democratic candidate for federal office, that is, the President and/or Vice President, elected or re-elected, will attempt an overthrow of the U. S. government
- The nation appears to be on the pathway toward a second conflagration or civil war, which will be difficult to avoid unless the right steps are taken and the right decisions are made by the American public
- The current situation and circumstances here in the U. S. A. and State of New Mexico did not happen by accident. Actions of the Democratic Party over many, many years have led to the existing state of affairs
- Institutions of higher education here in New Mexico are also responsible for the current situation and circumstances
- They have been educating and training revolutionaries, traitors, terrorists, and *coup d' étatists* for at least three or more decades
- The second civil war, as I see it now, is/has been/and will be in the future against Hispanic terrorists, invaders, and infidels who have entered the U. S. A. and become citizens under false pretenses
- They have only come to the U. S. A. for their, and their families, economic enrichment
- Many Hispanics never were, wanted to be, or ultimately became loyal and patriotic, citizens of the U. S. A. who wanted to live under our Constitution and the rule of law
- Currently, as far as I can tell, there is no law and order in Las Cruces or Doña Ana County. Community criminals, vandals and terrorists are running amok
- Society and civilization here is chaotic, anarchic and deteriorating

- As my wife and I appear to be the only “Loyalist troops” on the ground here in the war zone of New Mexico, we are in urgent need of reinforcements
 - I have previously asked for federal and State support and assistance but have received neither
 - If certain actions are not taken prior to the national election late next year, they will be required after the election. Of course, delaying actions will result in making the state of affairs increasingly dire over the next year
 - Among the specific precipitating circumstances that have led to this state of war are the refusal of many Hispanics to integrate into the U. S. A. and their refusal to adopt the English language to use in everyday life and living
 - It should be understood by all Hispanics that we are not a Spanish-speaking or bilingual nation, and we never will be
 - Our nation was founded by English-speaking White, Anglo-Saxon Protestants who had a specific vision for what the U. S. A. was and should always be based on the ideals and principles of the Declaration of Independence and the U. S. Constitution
 - All Hispanics swore to speak English, abide by U. S. laws, and to live under the U. S. Constitution when they became citizens of our country
 - Many, if not most, Hispanics are not doing those things now, and have no interest in integrating into the Anglo, English-speaking U. S. A.
 - All of these Hispanics should be considered non-citizens, enemy combatants, revolutionaries, traitors, terrorists, and seditious *coup d’ é tatists* to our government, and be subject to expatriation or the death sentence
 - The many Hispanics who are and have been loyal citizens of the U. S. A., are speaking English, support the U. S. government, Constitution, and laws of the U. S. A., should have nothing to fear, but should not become involved or entangled in the ongoing conflict
 - The active civil war engagement, if it comes to pass, should be as limited as possible in order to put the nation back on the road to peace, recovery, and prosperity as soon as possible
 - The federal government has a responsibility to protect law-abiding, peaceful, loyal and patriotic citizens of the U. S. A., especially Anglos, here in New Mexico
