



ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 57

- Good afternoon, my fellow Americans. I am Roy Merritt and I am running as a candidate for President of the U. S. A. in 2024
- This is Campaign Speech # 57, an impromptu speech, precipitated and necessitated by new terroristic acts committed overnight and this morning by Democratic Party terrorists, traitors, revolutionaries, and *coup d' étatists* here on southern New Mexico
- Most of you already know about and are familiar with many of my platform proposals
- I am seeking the return of the death penalty for domestic terrorists and acts of domestic terrorism. This would especially and necessarily include anyone who has done terrorism and committed terroristic acts here in southern New Mexico over the past three-plus years against my wife and myself as long-term, loyal patriots and patriotic representatives of the U. S. A.
- In relation to the last proposal, it should be noted that all federal, State, County, city of Las Cruces, and NMSU officials, and all law enforcement in the State of New Mexico have known about the terrorism, crimes, acts of vandalism, and just plain EVIL that my spouse and I have suffered with and through over the past three-plus years, since the beginning of the Biden administration, and have done nothing about it
- Removal of the State of New Mexico from the Union of American States for a minimum period of ten years
- Hanging high-level federal, State, County and law-enforcement leaders who have been overseeing, are in charge of and responsible for the acts of terrorism against my spouse and myself over the last three-plus years here in southern New Mexico

- **Death penalty by hanging all high-level government officials guilty of terrorism, treason and other high crimes**
 - **Potentially, the death penalty for any new acts of entering the U. S. A. illegally**
 - **Expatriation of all non-English speaking citizens—especially all illegal Hispanic immigrants still speaking Spanish as their primary language after three years in the U. S. A.**
 - **Closing down NMSU (or, NMSTU, as I refer to it) and UNM in Albuquerque as long-time terrorist training and education centers**
 - **Firing all police and law-enforcement officers in the State of New Mexico, and hanging all leaders and captains, and to include the Sheriff(s) and acting Sheriffs of Doña Ana County, since the beginning of year 2020**
 - **Destroying completely all terrorist camps and enclaves in Doña Ana County, across New Mexico and the U. S. A.**
 - **Terror Squads and Citizenship Tribunals**
 - **Identifying and designating officially Domestic Terrorist Centers (DTCs) across the U. S. A., including Las Cruces and Doña Ana County**
 - **Closing down permanently and eliminating Doña Ana County as a political unit, firing all current employees, and expatriating and possible death penalty for some workers**
 - **Making eligible for the death penalty anyone who has worked on our property since my spouse and I returned here to New Mexico in 2020, and who have committed criminal, terroristic, vandalistic, and treasonous acts against us, especially on multiple occasions**



- Furthermore, in general and in relation to these major proposals, I would ask the American people, at this time, NOT to vote for anyone for President in 2024 who doesn't have an intimate awareness of the acts of terror and treason here in the State of New Mexico, of the State's failure to live under the U. S. Constitution and the rule of law and order, and of the silent secession of the State from the Union of American States

- As I have indicated on multiple occasions before, the State of New Mexico is lost, and should be designated officially as the first international State of Terrorism in the U. S. A. It is no longer living under the U. S. Constitution and the rule of law and order

- One of my initial acts as President, should I be so elected in 2024, will be to withdraw the State of New Mexico from the Union of American States for a minimum period of ten years


- More serious actions can and likely will be required to get the U. S. A. back on the track of improving civilization

- Again, Americans should not consider voting for anyone who doesn't believe that the U. S. A. has some very serious domestic problems, including out-of-control domestic terrorism accompanied by rampant criminal activities and vandalism. These problems are not going to fix themselves and will have to be attacked head-on. Think about your vote long and hard. The actions of the electorate may very well spell doom or not for our country

- Thus, in summary, the terrorism and terroristic acts continue here in southern New Mexico in year 4 of our renewed tenure

- The major crimes and vandalistic acts continue

- The "Grand Conspiracy" continues
