ROY D. MERRITT FOR U. S. PRESIDENT CAMPAIGN SPEECH # 45

• Hello, I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024

• My speech today forms part of my political platform, which is established by all of my prior speeches and political publications. Obviously, my platform will endure whether I am ever elected president of the U. S. A. or not

• Early on in my campaign, I told the American people that I did not feel that I was "radical" in any area other than the punishment phase

• We MUST have harsher and more severe penalties, punishments, and sanctions if the U. S.A. is ever to get back on the right track. This is largely due to the fact that civilization has stalled, not continued to improve, and has seemingly reversed its course since the turn of the 21st century

• The other day, in an impromptu announcement, I asked that the U. S. Congress pass legislation creating Domestic Terrorist Centers, or DTCs, all across the U. S. A. where warranted. Camps or enclaves, towns and cities, and Counties and States would be eligible to be designated as such

• Because it is oftentimes difficult to establish exact guilt in every situation, all people of a DTC should be punished in one or more ways (e.g., through taxation or federal funds withdrawn from an area)

• High-level government officials in responsible positions for stopping domestic terrorism involving large numbers of people (e.g., in a city, County, or State), especially over a long and drawn-out period of time, should be made eligible for the ultimate sanction—the death penalty

• As relates to increasing penalties, punishments, and sanctions across the board, I have put forward a lot of suggestions and ideas for the American people to consider:

- (1) The creation of new reform schools, re-education, or reorientation centers;
- (2) Prison farms, or modern-day "gulags," for more severe criminals and vandals;
- (3) Capital punishment in the form of hangings or some equivalent methodology for serious offenses like domestic terrorism and treason. Many more people need to be made eligible for capital punishment for similar serious crimes in the U. S. A.;
- (4) Expatriation of large numbers of people who cannot seem to adjust to living in U. S. society under the U. S. Constitution and laws of the U. S. A. There should be automatic expatriation of immigrants upon the commission of their first major domestic criminal offense;
- (5) Relocation centers located in island territories of the U.S.A. in the far Pacific Ocean where individuals to be expatriated could be moved to;
- (6) Mandatory minimum sentences for all of the 20 or more newly defined forms of terrorism, and much more serious sentences for prolonged and repeated offenses (e.g., trespassing, property invasion, and entering the country illegally);
- (7) Citizenship tribunal reviews to re-evaluate whether individuals originally granted citizenship in the U. S. A. in the last quartercentury or so, have met all the requirements of citizenship, especially to include learning and using the English language as their primary language of communication in everyday life in the U. S. A.;
- (8) The utilization of para-military Terror Squads to "root out" domestic community terrorists from terror camps or enclaves in

- (9) Ten-year prison terms for any County, city, or State official committing acts of reprisal and retribution against private citizens, including trespassing, acts of vandalism, property destruction, the facilitation or expediting of property damage or destruction against private citizens, or any single act of domestic terrorism (for example, *patriotic terrorism*—damaging, destroying or removing a U. S. flag from the property of a private citizen; also for harassment, intimidation or aggravated monitoring of private citizens on their private property;
- (10) The immediate expulsion from the U. S. A. for immigrants turning against the U. S. A. and committing terroristic and treasonous acts

• According to the Declaration of Independence, when governments become destructive of the ends of guaranteeing private citizens the unalienable rights of life, liberty, and the pursuit of happiness, then it is the right of the people to alter or abolish it, and to create a new government or governing entity that is most likely to serve the people's needs for safety and happiness

• When an absolute, despotic government commits "a long train of abuses," it is the duty of citizens "to throw off such government"

• It is for these reasons and based on the continued abuses of governments at all levels (subdivision, town and city, County, State and federal level) against my spouse and myself over the last three-plus years, that I make the following recommendations as a candidate for the presidency of the U. S. A. and as a part of my enduring political platform:

- (1) Designate the State of New Mexico as the "First State of Terrorism" in the U. S. A.;
- (2) Designate "Terror Valley," located on lower Dripping Springs Road in Doña Ana County, New Mexico as a major *terrorist camp or enclave*;

- (3) Designate Las Cruces, New Mexico as a *Domestic Terrorism Center*, or *DTC*;
- (4) Designate Doña Ana County, New Mexico as a *Domestic Terrorism Center*, or *DTC*;
- (5) Designate New Mexico State University in Las Cruces as a terrorist, traitor and *coup d' étatist* training and education facility;
- (6) Remove the State of New Mexico from the Union of American States, and move it back to territorial status for an indeterminate, but temporary period;
- (7) End Doña Ana County's "reign of terror" by closing it down, firing and replacing all high-level employees (including law enforcement), reconstituting and renaming the County;
- (8) Fire and replace all law enforcement and police in the State of New Mexico;
- (9) Close down, reconstitute, or relocate New Mexico State University such that it is, and cannot be any longer, a State facility sponsoring terrorism; and
- (10) Make eligible for consideration punishing for terrorism and treason all high-level State and federal government officials, to include but not limited to, named positions as applicable (President, Vice President, Governor, Lt. Governor, and Attorneys General) in New Mexico and Washington, D. C. with the ultimate sanction or the death penalty
