

ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 53

- Hello, again, my fellow Americans. I am Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024

- This is Campaign Speech #53. It is different from my former 52 campaign speeches, as I very recently—within the last few days—suffered a major attack on my abilities to develop and reproduce my presidential campaign speeches by the Democratic Party-Hispanic terrorists of “Terror Valley,” New Mexico; Las Cruces, New Mexico; Doña Ana County, New Mexico; New Mexico State Terrorist University, located here in Las Cruces, New Mexico, where I garnered my doctoral degree in 1994; also by the State of New Mexico, under the Governor of New Mexico, Santa Fe; and by the federal government under President, Traitor Joe Biden; the Vice President, and Attorneys General of New Mexico and Washington, D. C.


- I do not know at this time the full extent of damages that has been done to me and my infrastructure, computer hardware and software, electronics, and other capabilities such that I am able to continue to conduct my campaign, except that I am heavily damaged, and know not now if I will be able to recover

- However, I have warned you previously about how evil these people are and about their capabilities. I do believe that this is the first step, and an essential one, in their plan to overthrow the legitimate government of the U. S. A., and to install an authoritarian, dictatorial leader

- In the meantime, I will have to produce my speeches free hand and deliver them to you in person, likely daily, from my home and property here in Las Cruces, NM

- I must alert you again though, that it is just me and you—the American electorate—that can stem this counter-revolution—and set things right again

- This most recent attack was a tyrannous act and was most likely conducted in concert with other operatives and agents whom I am not aware of at this time

- I have told you several times though how I am alone and vulnerable here. I do need help, support, and reinforcements in order to continue my campaign. I have suffered a devastating blow, and it will be difficult for me to recover from this most recent attack
 - It does let you know the type of people that I and America are dealing with now. And, as I have reported to you before, I believe our country is in deep, deep trouble
 - This campaign speech, # 53, was to be about a broad and deep conspiracy, long-standing and long-ranging, involving all of the disparate elements and parties that I have told you about before
 - Everything that has been done to me, my spouse, and our property here in Las Cruces, New Mexico is completely outside the bounds of everything I know about and have been dependent on during my lifetime—outside all of the laws of our land, the U. S. Constitution, Bill of Rights, Declaration of Independence, and government leaders and offices at all levels in our country—local, city, County, State and federal
 - Obviously, I need to be more concise in producing and bringing forth information on a daily basis to your attention
 - I will not immediately be able to organize my speeches and presentations as effectively as I have done previously, and my enemies, your enemies, and our country's enemies know that this will be the case, and that is why they have made this most recent attack on me and my campaign
 - Today, I will just try to itemize, likely in no certain order, some of my major concerns related to this deep, dark and long conspiracy that has been on-going and active for many decades here in the U. S. A.
 - All that I can say now, at the beginning, though, is that this—that is, America is NOT the country that I thought it was, and knew and loved. It is something else, but I know not what at this time
 - I want the people of all of the States of the U. S. A. where I have lived and worked to come along with me now, in this new journey that I am beginning today. I know not where it will lead, but I do know that I need your help, assistance and support. These

States again include WV, KY, IN WY, AK, NM (twice, 30 years apart), TX, NH, MN, NY and NM again

- First, there is a real or *ex facto* union of criminal workers that are involved in this on-going broad and deep conspiracy, at least here in southern New Mexico, that must be brought to account
- I previously told you that I believe that most everyone here in the local area are deeply involved in this conspiracy, including all law enforcement in the State of New Mexico
- The two major universities—NMSTU and UNM—and their leaders are an important cog in this conspiracy and have been since at least my first tenure here in the State of New Mexico from 1988-1996
- All members of the Democratic Party, and many, if not most Hispanics are working in concert, collusion, and conspiracy to bring down and destroy the U. S. of America
- There are local terrorist camps and enclaves, like “Terror Valley,” New Mexico that are heavily engrained in this conspiracy. These are the people that I have previously described as the most evil *or* vilest, terroristic, criminalistic, and vandalistic ever on our planet
- These camps and enclaves are essentially cults, and they are scattered across New Mexico, and as far as I know, are also scattered about our country now in many of the other States of the American Union
- As I said earlier, law enforcement is working in concert and partnership with the terrorists, traitors, criminals, and vandals of the Democratic Party—Hispanic-led conspiracy here in New Mexico and all across the U. S. A.
- All of the members of the conspiracy regularly connive and conspire with others of the group in doing their on-going illegal and unlawful acts
- As far back as my Campaign Speech # 15, I asked for a special Congressional inquiry to determine if an active conspiracy was in the works to overthrow the legitimately elected government of the U. S. A.

• Government officials, law enforcement, criminal workers' union members, criminal gangs/lawbreakers/and terrorists are working in concert and cooperation to usurp the U. S. Constitution and the rule of law and order in our nation

• I have previously referred to this conspiracy in several of my speeches as a grand plot, "Grand Symphony," and tragic opera that is now unfolding in our nation

• One or more States, including New Mexico, have already seceded from the Union of American States, and Hispanics, as an ethnic group of mostly illegal and criminal, and terroristic citizens have dis-affiliated themselves from other Americans and are going their own way, after a silent coup and secession, likely many years ago, perhaps several decades


• Again, this conspiracy involves Democratic Party conspiratorial operatives at the federal level, and at the State and Doña Ana County levels here in New Mexico, and certainly terrorist operations from the two major higher-level educational institutions here in New Mexico

• This conspiracy, involving all of the disparate elements I have recounted, is secretive and treasonous, encompasses criminal plotting and planning, and is characterized by collusion, connivance, and machinations with intrigue, sedition and treachery

• The individuals involved, including most, if not all Democratic Party Hispanics of all walks of life here in New Mexico are all co-conspirators, traitors, and terrorists. They are highly organized, determined, resolute and dangerous in their goals. They are uncompromising, unrelenting, and cannot be pacified. They are unyielding, not amenable to making adjustments or altering their plans by begging. They are stubborn, will not submit, and cannot be managed or governed

• I will end this diatribe where I began, and state again that my campaign for the office of President of the U. S. A. has suffered a severe blow and attack from the Democratic Party –Hispanic terrorists and conspiratorial operatives here in New Mexico and at the federal level

• For now, it is enough I believe, that I recount briefly exactly who are my enemies and the enemies of the U. S. A. All leaders and law enforcement in the State of New Mexico.
