


**ROY D. MERRITT FOR U. S. PRESIDENT**  
**CAMPAIGN SPEECH # 55**


- Good afternoon, my fellow Americans. I am Roy Merritt and I am running as a candidate for President of the U. S. A. in 2024
- This is Campaign Speech # 55
- Since my last speech on Saturday afternoon, I believe that certain clandestine methods have been ramped up in an effort to shut down my campaign
- My last speech, Campaign Speech #54 was also referred to by me as “Sermon on the Mount II.” I also published on the town square my second political campaign book on Saturday evening, and it appears that pressure has been increased across the board to try to shut down my campaign since then
- That second political campaign book, entitled *Rekindling Meritorious America: The U. S. A. Under the Merritt System*, can be reviewed in draft form near the front gate of our home and property here in Las Cruces, New Mexico
- I now believe that methods of torture are being used against me and that these *modus operandi* have increased in their intensity over this past weekend
- However, actually, other methods of torture and pain infliction have been used against me the last several years, essentially since the start of the Biden administration, in addition to trauma and acts of terrorism
- Thus, I think that clandestine methods have been used against me all along but I didn’t know exactly when they began or were first ordered
- The orders to implement them against me came down from the highest levels of the American government

- Perhaps a decision was made at the beginning of the current administration at the federal level that they needed to consider people like me as enemies of the State and that certain methods and tactics were approved and ordered at that time to go after me with whatever “tools” were at their disposal to close me down
  - At this time, I do not believe that I should give you details on what I believe are the torture methods being used other than that they are extremely sophisticated, and that I am in extreme pain from their use during parts of every day
  - Of course, I have to some degree been under considerable mental and physical pain for the past several years and that is why I originally announced my candidacy to run for president of the U. S. A.
  - I also believe that my spouse has also been subject to certain of these methods of torture at different times. I know it seems that she has been under threat all along in the sense that authorities have attempted to use her in an effort to close down my campaign
  - However, presently, I think that the methods of torture being used have now shifted back to me
  - Some individuals locally have approached my spouse to ask whether I was really running as a candidate for president of the U. S. A. or not. On the surface, this type of inquiry would seem very strange to begin with
  - Obviously, I have just as much right to run as a candidate and to make my speeches as the next person
  - Based on everything I know at this time, it is my strong belief and suspicion that there are elements of the U. S. government, and at the State, County, and local levels, that have declared “war” on me personally and on my campaign in an attempt to force me to shut it down unwillingly on my part
  - Thus, there are people both at the federal level and State levels here in the U. S. A. that are so afraid of me that they have taken out all stops to try to close down my candidacy for the presidency of the U. S. A. The elements of the government, again, are using all of

**the methods at their disposal, including terrorism and torture, to try to stop me from moving forward**

- Because of these charges on my part, I believe that I will have to keep disclosing some details on the methods of torture that they are using against me, as I am uncertain at this time whether I will be able to continue my campaign unless these tactics and methods are stopped**
- The tactics and methods that I am referring to have been ramped up since this past summer, when I made it known publicly that I suspected a conspiracy was in the works to overthrow the legitimately elected democratic government in the U. S. A.**
- About a year ago as well, I came forward with information on what I considered the silent secession of New Mexico from the Union of American States. At that time, I also identified the parties that I believed were responsible for this. Those named by me included the President and Vice President of the U. S. A., the Governor and other high-level officials in the State of New Mexico, government leaders of Doña Ana County and the city of Las Cruces, New Mexico, the leaders of the terrorist camp or enclave I refer to as “Terror Valley,” law enforcement throughout the State of New Mexico, and the leaders of the two largest universities in the State of New Mexico—UNM in Albuquerque, and NMSTU here in Las Cruces, New Mexico, where I attained my doctoral degree in 1994**
- Furthermore, I continue to come forward almost daily with new information on my charges of the use of terrorism and terroristic acts by Democratic Party-Hispanic operatives here in the State of New Mexico over the past three-plus years, against my spouse and myself, and our property just outside the city of Las Cruces, New Mexico, in the County of Doña Ana**
- Different terroristic tactics and acts of terrorism have been implemented, and still are, by local forces of the Democratic Party, the County, the State, and the federal government**
- My spouse and I continue to be under attack from these forces of the Democratic Party, presumably all or nearly all are Hispanics primarily because I refused to provide cover for the State’s silent coup from the Union of American States**

- As I have reported many times during this campaign, the State of New Mexico is no longer living under the U. S. Constitution and the rule of law and order
- I have said all along that I believe there are many people locally who know what is going on here, both at local and State levels of government in New Mexico, but they are also under threat and are afraid to come forward
- For these reasons, I believe that the U. S. government should offer a substantial award (perhaps \$2-3 million) for individuals who come forward with direct first-hand knowledge on the tactics and methods that are being employed by these terrorists and traitors to the U. S. A.
- I know that it is unusual to have forces attempt to close down an election approximately a year before people go to the polls to vote. I don't know, however, if there has been a U. S. election in which the winner has been decided and declared so early in the process without the American electorate having a "say" in the matter
- National elections in the U. S. A. have seemingly become increasingly suspect, and possibly fraudulent, in the last several presidential elections. After the Bush-Gore election of 2004, it seems that the last several elections have been somewhat suspect, but forces seem to be lined up way too early in the 2024 election to declare a winner without giving Americans an opportunity to vote
- That is why I believe it is imperative that the 4<sup>th</sup> estate, and the world news media watch over this election to make sure that it is fair, open, and free of fraud
- Obviously, there is already a lot of information and details out there that need to be reviewed and corroborated by elements of the world news media, if for no other reason than to make sure that the U. S. election in 2024 is honest, above board and without fraud
- As far as events here in New Mexico are concerned, I have told the media previously about what I thought was going on, but I don't believe that they have been able to come forward to report news on this situation because there appears to have been a "clamp down" decision early on by the news media, either willingly or unwillingly, that they were not going to cover my candidacy or to consider me a legitimate candidate for president of the U. S. A.

- I suspect that my candidacy and my proposals have been considered politically incorrect and incendiary by at least some, if not most, of the national and worldwide news media, perhaps following orders emanating at the federal level early on
  - Whether I am informed of it or not, I need elements of the world news media to watch over my campaign, to protect me and also the U. S. A. from elements in our nation that are bent on destroying our country
  - I would like, want, and expect that the world media use its political power and influence to force elements in the U. S. A. to cease and desist in what they are doing and to leave me alone, and also not to interfere any further with me as a candidate in the presidential election of 2024
  - I believe that at least a few representatives of the world media should descend on Las Cruces and Doña Ana County, New Mexico to try to ferret out facts on exactly what is going on in this situation—with the torture, terrorism and treasonous activities—and hopefully find informants to come forward with factual information about the apparent conspiracy and wide-scale criminal activities in the State of New Mexico
