



ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 40

- Welcome, again, to all of my fellow Americans from Rancho del Arroyo, our property and home here in south-central New Mexico. I'm Roy Merritt and I am running as a candidate for the presidency of the U. S. A. in 2024
- I would especially like to say "hello" again to everyone in the States of TX, NY, MN, AK, WY, NH, IN, KY, WV, and of course, NM
- This is Campaign Speech # 40, which is an important one from my perspective
- Candidates who are running for the presidency of the U. S. A. tend to have superegos and think that the whole election process is about them, but in the end, it's not about them at all. It's about our country and our Constitution and our democracy and our republic and preserving our nation far into the future
- Not all candidates are the same, and are not necessarily even talking about the same things as being important to our nation at the present time
- According to the polls, I guess the American people feel that either Traitor Joe Biden or Do-Over Donald Trump should be re-elected for a second term, and it's uncertain whether either of them know what the most important issues are now, and what issues they should be talking about to the American people during the 2024 campaign
- There are other candidates in the race for the presidency, but most are unlikely to have any bearing on the ultimate outcome
- I am in the race as a candidate not necessarily to be elected the next president but to develop a political platform that I think is the most vital to our nation as we proceed further into the 21st century. Thus, I believe that I am talking about the issues that we need to be focusing on in 2023 for the good of our nation and Planet Earth
- Today, in my 40th campaign speech, I want to talk about the other candidates in the race for the presidency in a general sense and what they should be talking about in this race
- For example, if you are a candidate running for the presidency of the U. S. A. in 2024 and you are NOT talking about fixing the State of New Mexico, and any other State of the U. S. A. with the same problems as New Mexico, then you are in my view a minor, inconsequential and illegitimate candidate

- If you are a candidate and are NOT talking about fixing New Mexico, then you are also NOT talking about fixing and saving America, no matter what it is you have to do, then you are a minor, inconsequential and illegitimate candidate for the presidency of the U. S. A. in 2024
 - If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT talking about what to do with higher-level educational institutions that are ultra-liberal, revolutionary, seditious, and *coup d' état* against the U. S. government and Constitution, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024, and are NOT talking about what to do with the terrorists and traitors to the U. S. A. running amok in our communities, towns, cities, Counties and States, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT talking about local, County and State governments working in concert with criminal elements, and attacking and perpetuating crimes, vandalism and acts of terrorism against their own citizens, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT talking about the denial of Constitutionally guaranteed rights, freedoms and protections to many U. S. citizens, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT talking about immigrants who have immigrated to the U. S. A. in the last quarter-century or so refusing to integrate into American society, AND to become productive citizens of the U. S. A., and instead turn into terrorists and traitors to our nation, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT specifically talking about what to do with Hispanics from Mexico and the central and southern Americas who have turned against their country and countrymen, and determining what to do with these people, many of whom are now living isolated lives in our communities apart from other Americans, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT talking about all of the new forms of terrorism (e.g., patriotic terrorism and environmental terrorism) affecting our nation and our people, then you are a minor, inconsequential and illegitimate candidate

- If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT talking about making our nation and our planet more civilized places in which to live in the 21st century, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT talking about working to find and implement conserving solutions for Planet Earth as well as for our nation, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024 and are NOT talking about accelerating the search for an extraterrestrial off-ramp—another planet or planets in our galaxy or beyond—where earthlings can begin to be relocated to relieve some of the extraordinary pressures on Earth, then you are a minor, inconsequential and illegitimate candidate
 - If you are a candidate for the presidency of the U. S. A. in 2024, and ARE talking about some or all of these issues, then you also need to explain to the American people during this campaign why they are vitally important to our nation and its continuance into the future as one of the leading countries in the world and on our planet
 - For example, if States of the U. S. A., like New Mexico, are not forced to live under the U. S. Constitution and to enforce the rule of law and order, then we no longer have a country
 - If we no longer have a country and a Constitution, we no longer have Constitutionally guaranteed rights, freedoms and protections in the U. S. A.
 - Our original American Revolution and our Declaration of Independence are no longer valid
 - All of the work of America's Founding Fathers and all of America's founding documents are null and void, and useless
 - And if the U. S. A. as a unique, special and exceptional nation is lost, then it is not only a loss for the world but also for Planet Earth and the chances of the human species to survive long enough into the future until we can find a new home for mankind somewhere in our galaxy or beyond in the universe
