## ROY D. MERRITT FOR U. S. PRESIDENT CAMPAIGN SPEECH # 13

- I am Roy Merritt and I am running as a candidate for the Presidency of the U. S. A. in 2024.
- Because of existent circumstances here in New Mexico over the past 3+ years, and recent new developments, I have renamed my campaign "NOT ALL...DEMOCRATS ARE TERRORISTS!" It now appears though that most Democrats in New Mexico are.
- My wife and I were out of town over the past two nights, and we returned to find that multiple new acts of terrorism had been committed by Democratic Party terrorists on our property while we were away. This is and was nothing new, and happens almost daily and nightly here in Las Cruces and Doña Ana County, New Mexico.
- Those responsible for these acts of terrorism are:
  - (1) The President and Vice President of the U. S. A.
  - (2) The Governor and other high-level officials of the State of New Mexico
  - (3) Doña Ana County
  - (4) The city of Las Cruces
  - (5) New Mexico State "Terrorist" University
  - (6) All law enforcement in the State of New Mexico and the U. S. A.
- When I become President, we are going to have to change a lot of the terrorism laws to include such acts as home, property and privacy invasion, country invasion and illegal-unwanted immigration to the U. S. A., trespassing, property destruction and vandalism, and hate crimes by one ethnic group of citizens against another.
- As I have repeatedly told you, all of what I originally called crimes and vandalism against us and our property over the past 3+ years, I now call terrorism.

- In the future, we will need to classify different levels of terrorism to include acts by one ethnic group of citizens against another, such as those that have been done to my wife and myself, and our property, over the last several years
- I also believe that we are going to have to declare the invasion of citizens from the other Americas into the U. S. A. as acts of terrorism in the future
- I know that I am terrified of you, and I have been terrified of you since we retired here in 2020
- I have recently developed new definitions and examples of over 20 new types of terrorism based on the criminal and vandalistic acts you have committed against my wife and myself, and also the denial of our guaranteed U. S. Constitutional rights, freedoms, and protections
- These new types of terrorism also include the refusal of law enforcement in New Mexico to enforce the laws of our country, our State, County, and city, and also their failure to protect and defend citizens like myself and my wife, and our property, any longer
- Discrimination by business owners of one ethic group against an individual like myself of another ethnic group has to be classified as terrorism that is punishable by expatriation of the business owner and his family, revocation of his/her license to do business in the U. S. A., and the permanent closure of his or her business
- Crimes such as extortion, scamming, acts of reprisal, refusal to do service, repairs, or business in general, based on ethnic differences and discrimination, should and will, if I have my way, be considered as a class of terrorism punishable by law, possible expatriation, and possible loss of livelihood in the U. S. A.
- Economic and retributive constructive trade/building criminal acts will also fall into this general category. Examples would include charging clients and customers multiple times for the same repair(s) that you, as an individual contracting agent were responsible for causing in the first place. For example, repairing the same roof leaks multiple times and telling clients that they need a new roof when they don't
- Planned but avoidable acts of negligence and purposeful poor building/construction practices like not sealing and insulating doors and windows

against preventable water, wind, dust, and storm damage in new houses, and unwarranted flooding underneath doors and into the rooms of houses

- Other examples of possible new classes of terrorism would include:
  - (1) Repetitive, planned, purposeful acts of environmental terrorism
  - (2) Repetitive, planned, purposeful acts of property destruction and vandalism
  - (3) Repetitive, planned, purposeful acts of home and/or property invasion and trespassing
  - (4) Patriotic terrorism in the form of U. S. flag(s) attack, desecration and destruction by one ethnic group of citizens against another
  - (5) Issuing threats of harm that instill fear of future terrorism or terroristic attacks involving individuals of one ethnic group against another
  - (6) Denials of another citizen's freedoms of speech, expression, publication and press, religion, association, etc., if it involves a form of discriminative attack by one ethnic group against another
  - (7) Planned and/or purposeful county, city, State, or federal government actions/inactions against private property owners
  - (8) Reprisal attacks of a government, or of private contractors, against private property owners
- Terrorism and terroristic acts can be a way of life and living. They seem to pervade every aspect and all facets of life and living in the State of N. M. Almost anything of a retributive nature or reprisal attack can be considered an act of terror
- As you know, I am running for President of the U. S. A. <u>against</u> my home State and State of residence—New Mexico.
- Free speech and the communication of ideas in America have to be heard whether we like them or not.
- Some groups of citizens appear to be their own worst enemies.
- For example, there appears to be a ruling majority of people now in the State of New Mexico who are Democratic Party terrorists as an everyday way of life and living. These terrorists are also war criminals and traitors to the U. S. government and to the Constitution of the U. S. A.

- Thus, although "NOT ALL DEMOCRATS ARE TERRORISTS...," it appears that the President and Vice President of the U. S. A., the Governor and Lt. Governor of New Mexico, Federal and State Attorney Generals, and most citizens of New Mexico ARE!!!
- As I stated in prior speeches, I now believe that Hispanic Americans in New Mexico are a clear and present danger to the U. S. A. Generally speaking, I have learned to respect American citizens of all other ethnic groups more than I do most Hispanic Americans in New Mexico
- With Hispanic Americans, it has always been: "Give me, give me, give me!!!" I don't believe that there is another ethnic group that has demanded so much as new immigrants to the U. S. A., and you continue to do so. You are no more special than people of any other ethnic group.
- This situation is a cancer growing on our nation that has to be excised.
- There is already a silent, subliminal war going on in the State of New Mexico, and perhaps even in the U. S. A. as a whole. That is why I refer to these Democratic Party terrorists as "war criminals."
- I have previously declared that New Mexico is the first State of Terror in the U. S. A.
- Doña Ana County is a terror organization that has operated against me and my family for over three years—since I retired here in early 2020. The current governance and structure of Doña Ana County has to be destroyed
- Las Cruces is a terror town and city
- New Mexico State "Terrorist" University is the first named terror university in the country. Based on my own experience and observations, it has been training revolutionaries, traitors and terrorists to our nation since at least 1990. It now has active terrorists throughout the community that it has trained in the past to work toward the overthrow of the U. S. government and the Constitution of the U. S. A.
- Terror Valley, otherwise known as "Lake Lucero" subdivision, and what I unfondly named "Clusterfuck Park," is a terrorist camp that must be dealt with

for its leadership role in terrorism and treasonous acts against the U. S. government and the Constitution of the U. S. A.

- I believe that all Hispanics who have entered the U.S. A. since 1990 have to be re-evaluated in terms of their citizenship. I believe that Citizenship Tribunals and Terror Squads will be required in the State of New Mexico, and perhaps regionally throughout the U.S. A.
- If there isn't presently, there needs to be an apolitical Federal government agency, free of Executive/Administration influence, that can get involved to protect citizens against these types of terrorism and terroristic acts in the future
- I know that my life has essentially been destroyed, at least in the way I wanted to live it, since I returned to New Mexico for my retirement in 2020. Terrorism and terroristic acts have decimated my family life, relationships and associations, general welfare, overall good health, peace of mind, happiness, recreational and creative pursuits and interests, leisure, work requirements and habits, retirement career goals and objectives, discretionary use of income, travel and vacation plans, and numerous other aspects of life and living in the U. S. A.
- I believe that someone has to pay for this, and this is the reason that I am running for the office of President of the U. S. A. in 2020.
