


**ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 23**

- I'm Roy Merritt and I'm running for President of the United States in 2024.
- I'd like to send out a big "hello" again to all of the people of the States of the U. S. A. where I have lived and worked over the years: **TX, NY, AK, MN, IN, KY, WY, WV, NH**, and **NM** twice 30 years apart (1988-96) and (2020-present).
- The Democratic Party in N. M. and across the U. S. A. has now fully morphed into the party of terrorism and terrorists
- Of course, the Democratic Party is now led by the President of the U. S. A., Traitor Joe Biden
- Traitor Joe's VICE is now a Democratic Party Hispanic terrorist, traitor, and revolutionary *coup d' état* from New Mexico, the 1st State of Terror in the U. S. A., and the state where I also hail from
- My wife and I returned to New Mexico in February 2020 to take up residence in our newly constructed house in Las Cruces, which is located in the south-central New Mexico County of Doña Ana
- We had previously resided in New Mexico from 1988-1996
- Sandy and I initially lived in Albuquerque for 1.5 years while I assumed residency in a new doctoral program for me in geology
- However, after a year, I was unable to meet the stringent requirements into the program. This is after completing a 3-year doctoral program in geology at the University of Alaska in Fairbanks. I ultimately passed everything in this program except one portion of my final comprehensive examinations
- My wife and I moved over 4,000 miles in a U-Haul truck to New Mexico in the Summer of 1988

- We moved to Las Cruces, New Mexico in 1990 for me to begin a new doctoral program in Curriculum with a specialization in Science and Environmental Education at New Mexico State University
 - I completed that program and received my doctorate in May 1994
 - I wanted to remain at the University and continue to teach some lower-level graduate classes, but was told that “No, you cannot remain; you should go away, but perhaps you will be able to return to the university at some point in the future.”
 - I didn’t know at the time but this is exactly what did happen some 30 years later when I did return at Christmastime 2018 to hopefully purchase a retirement home in the Las Cruces vicinity
 - We were unable to buy a home at that time but we were able to find and purchase a 4+ acre plot of land along the South side of lower Dripping Springs Road in Doña Ana County outside of Las Cruces
 - We subsequently hired a contractor to build our new home and construction began in July 2019 and finished in February 2020, and we moved into the house on my wife’s birthday—the 20th of February
 - That first year back was during the early heavy stages of the COVID outbreak, and because everyone was mostly closed up in their houses, it turned out to be a fairly good year for us, and we were happy and felt blessed at Christmastime 2020
 - In January 2021, things changed dramatically and unexpectedly for us when construction began on a new house directly across the road from our house. That was just the first of several new houses that were constructed along or near the North side frontage of Dripping Springs Road
 - Our lives in Las Cruces have never been the same since

- We have suffered from every type of peace disruption, crimes, vandalism and terrorism since
- After over two years of all of this crime and vandalism, I finally reached the conclusion that this was not only just ordinary crime, etc., but was in fact multiple forms of terrorism dressed up to appear different and more innocent than it was in reality
- After reflection and study, it became clear to me that there were at least 20 or more different classes of low-moderate level terroristic acts that were being perpetrated against my wife, myself and our property
- One of the key characteristics was that these acts were seemingly being committed against us by pretty much everyone in the community—what you would call normal folks—community criminals, vandals and terrorists
- The different terroristic acts were being committed over, and over, and over, and over, and over, and over..., time after time after time
- These included all the different types of crimes and vandalistic acts that you can name—trespassing, property invasion, property destruction and desecration, property trashing and environmental terrorism, hate crimes, mischief crimes, discrimination, unlawful reprisals and retributive acts, harassment, intimidation, threats and warnings of harm, peace disturbances of all kinds, intrusions into and losses of our personal privacy and free communication in all ways possible, scamming/extortion/and other economic crimes including surcharges and overcharges on goods and services, robbing and stealing, denial of our guaranteed Constitutional rights, freedoms and protections, the denial of the rights and benefits of property ownership, patriotic terrorism involving repeated mutilation and destruction of U. S., N. M., and other flags, windsocks, and other symbols of patriotism, and religious terrorism in the form of tearing down and destroying crosses and other religious-faith symbols, etc., etc., etc., and etc.
- The County of Doña Ana has been a constant menace and terrorist to our peaceful existence since our arrival back in New Mexico in 2020. One employee

of the County informed me that he would not do anything for me that he wouldn't do for others

- I presume based on his statement that he would also harass, terrorize, and threaten them, that he planned to do and subsequently did do to us since
- The County was putting in a gas line for the city of Las Cruces along the North side of Dripping Springs Road at the same time our house was being constructed
- In doing so, they completely decimated two large areas of our property—about a half-acre section along the central portion of the lower 500 feet of road frontage and a half-acre section along the central portion of the upper 500 feet of road frontage
- They removed all the native plants, graded over these large areas, , failed to reclaim or revegetate the land, did not dig any drainage diversion and control features such as ditches, and hence made the land much more susceptible to flash-flooding and sheetwash damage to our overall property, including to the interior main house and compound, and to all of the xeriscaping features that I put in separately later to create two attractive, fully decorated, park-plaza-like areas with all types of dryscape, artistic and sculptural ground and plant beautification forms and designs
- We received little to nothing in adequate remunerative compensation for the destruction of these large land areas and the subsequent problems created as pertains to flooding and property destruction and damages after the fact
- Additionally, the County of Doña Ana has provided no law enforcement protection through the Sheriff's office for our personal property and lives
- As I indicated earlier, our U. S. Constitutionally guaranteed rights, freedoms and protections have not been afforded to us and have been denied, including freedom of speech and expression, freedom of religion, freedom of press and publication without harassment or destruction, and the freedom of willing association with others

- In short, our lives, happiness, peace and contentment have been completely destroyed over the past three-plus years by the city, county, and the State
- Our summary conclusion now is that our house sits directly across the road from a terrorist camp which I call "Terror Valley"
- Las Cruces is a terrorist town and city with a large fraction of the population composed of Democratic Hispanic terrorists, criminals and vandals
- Doña Ana County is a terrorist organization
- New Mexico is a Democratic State, a predominant Hispanic State and the first declared terrorist State of the U. S. A.
- In fact and in reality, most or almost all Hispanics are Democrats and members of the Democratic Party
- And, although as my campaign slogan says, "NOT ALL...DEMOCRATS ARE TERRORISTS...", most Democrats in New Mexico ARE!!!
- The Democratic Party in New Mexico, and I now believe across the U. S. A. as a whole, has now morphed into the political party of Terrorism and Terrorists
- All Democratic government leaders in New Mexico and Washington, D. C. are criminals, terrorists, traitors and revolutionary coup d' é tatists, who support the overthrow and usurpation of the U. S. government and the U. S. Constitution, and law and order nationwide
- Republicans, Conservatives, and most other mainstream political parties in the U. S. A., including political Independents, support the U. S. Constitution and the enforcement of law and order in our nation. In Addition, they are not for overthrowing our government and installing an authoritarian, dictatorial government. We are not generally criminals, terrorists, traitors and



revolutionaries, although we do occasionally make political mistakes and policy miscues

- As a candidate for the U. S. presidency in 2024, I now urge all Americans to think long and hard about whether they can continue to support the Democratic Party as it is currently constituted**
- Our country now needs to be rescued from chaos and anarchy at the hands of community criminals and terrorists, and be put back on the road to peace, prosperity, general welfare and happiness**
- I ask you now to vote for a candidate for U. S. President in 2024 who will protect, preserve and defend the U. S. A., its Constitution, and the way of life of the American people**
