


**ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 18**

- **I'm Roy Merritt and I'm running for President of the United States in 2024.**
- **I want to give a warm welcome to the people of all the States of the U. S. A. that I have lived and worked including AK, IN, KY, MN, NH, NM (twice 30 years apart) , NY, TX, WV, and WY**
- **The Democratic Party in the U. S. A. has now morphed into the party of terrorism and terrorists**
- **Hispanics and Hispanic Americans make up a large and growing segment of the Democratic Party**
- **Many of the top government officials at city, county and State levels in New Mexico are now Hispanics and Hispanic Americans, including the Governor of the State**
- **The State of New Mexico is the "1st State of Terrorism" in the U. S. A.**
- **Las Cruces is a town and city of terrorists**
- **Doña Ana County is a major terrorist organization**
- **The Sheriff of Doña Ana County is a Democratic Party criminal, terrorist, and traitor to the U. S. government and to the U. S. Constitution**
- **As the major law-enforcement officer of the county, he is not and has not been enforcing the laws of the county, the State or the federal government**
- **I believe that he and all Hispanic Democratic terrorists of New Mexico represent a clear and present danger to the U. S. of America, its government and Constitution**

- Doña Ana County is and has been supported by the Governor of New Mexico and other high-level State government officials, including the Attorney General
 - The Governor and Lt. Governor of New Mexico are and have been supported by the President and Vice President, and all other high-level government officials of the U. S. A.
 - All of these Democratic Party terrorists and traitors should receive the death penalty as soon after the national election as possible
 - Several law enforcement officers, including the Sheriff and several deputies of Doña Ana County came out yesterday morning to roust me as they have done a number of times previously
 - On a quiet Sunday morning, I had been touring our 4+ acre property to inspect for new terroristic acts and property damage that had been inflicted on my wife and me overnight by these Democratic Party terrorists, who have now infiltrated all levels of government in the U. S. A.
 - After 3+ years of undergoing terrorism by these same Democratic Party terrorists, I was naturally angry beyond all measure
 - I was shouting across the road to the People of Terror Valley to “Stop the Terrorism”
 - These same criminals, vandals, terrorists, and traitors to the U. S. A. and our Constitution called the police, and they came out to inform me that I could not yell at my neighbors
 - These are the same “neighbors” from Hell that have been doing acts of terrorism against us for the last several years
 - The criminal and terroristic acts and vandalism began in January 2021 at the same time these Democratic Party terrorists began to construct their home across Dripping Trash Road from my pre-existing newly built home

• My life has never been the same, and I have had no peace whatsoever since. These are the same Democratic Party terrorists that have essentially destroyed everything about my life, and they have the audacity and gall to call the police and complain about me yelling too loud

• Terror Valley sits directly across the road from our house. At least 8 new houses have been built there since construction on our house was completed in February 2020


• Terror Valley, which used to be called “Lake Lucero” and “Clusterf—ck Park,” is a large terrorist enclave, in a terrorist town and city—Las Cruces—of a terrorist county—Doña Ana—of a terrorist State—New Mexico!

• These Democratic Party terrorists of Terror Valley are also traitors to the U. S. A. and its Constitution, and are also the same ones who have not been enforcing the laws of our city, county, State, or nation since I returned to New Mexico for my retirement in early 2020

• It is truly hypocritical and laughable, that after not enforcing any laws whatsoever, and refusing to protect and defend my family and our property from these same Democratic Party terrorists and traitors for 3+ years would come out again in force to roust me again, for about the 5th, 6th, or 7th time the most peace-loving citizen of the area—a near 70-year old retiree to the “Terrorist State of New Mexico”

• All of these Democratic Party terrorists are Hispanics and Hispanic Americans as far as I know and suspect, and I now believe that they are part of a large active conspiracy to overthrow the government of the U. S. A.

• The Democratic Party has been setting up for this overthrow or silent *coup d’ état* for many, many years, at least since 1990

- These Democratic Party terrorists are part of what I would call an army of revolutionaries—many of whom have been educated and trained to leadership positions by New Mexico State “Terrorist” University
 - This I should know because my wife and I lived here in Las Cruces before from 1990-96. I received my doctorate from this same higher-education institution in 1990
 - I thus know personally that NMSU was educating and training revolutionaries, terrorists, and traitors to the U. S. government and Constitution
 - After my doctorate in 1994, NMSU told me to “go away,” and that maybe I could come back to the university someday. They indicated that they wanted and needed to hire another new bilingual faculty member from Mexico
 - I believe that bilingualism is good as long as it is fair, non-discriminatory and includes all languages
 - However, obviously, I was discriminated against in my own country, and a Spanish-speaking individual from another country was awarded with a “spoils’ system” position in an ultra-liberal State university of a State with a large and growing population of Hispanics—Spanish speakers as well as English in this case
 - For the general citizen of the U. S. A., though, speaking Spanish is not required or necessarily needed as English is the national language of the U. S. A. and is required and theoretically mandatory of all new citizens
 - Many of us in the U. S. A. speak multiple languages, but we are not obligated in any way to speak Spanish over any other languages
 - We can look back on this emphasis on speaking Spanish in the U. S. A. on the part of NMSU, as the beginning of a great revolutionary effort on their part to change the U. S. A. from “what it was” to “what they wanted it to be”

- Theoretically, all new citizens to the U. S. A. must speak English in order to obtain citizenship
 - In the U. S. A., these new citizens—including those from Mexico—are required to speak English
 - Allowing new citizens from Mexico to speak Spanish and making citizenship tests written in Spanish puts these same people on the path of being considered “special” and apart from the rest of the people of the U. S. A.
 - They are not in this case forced to integrate with citizens of the U. S. A. and to become a part of our nation’s completely equal English-speaking mass population
 - This, in my mindset, was the beginning of the revolution, and now the “war” that we find ourselves involved in
 - Illegal immigration and the subsequent invasion of a Spanish-speaking horde from Mexico and the other southern Americas has accelerated this initially “silent war” and “inactive coup” into the new “active war” and ongoing “silent coup” that we find ourselves in today
 - Spanish-speaking Democratic Party terrorists are now engaged in a civil war here in New Mexico against regular ordinary citizens of the U. S. A.
 - These Democratic Party, Spanish-speaking terrorists and traitors seek nothing less than the overthrow of the U. S. government and the creation of a Spanish kingdom and developing empire in North America
 - I believe that we are now approaching the climax of a long-active conspiracy to overthrow the U. S. government by these Hispanic terrorists and traitors of the Democratic Party
 - The overthrow of the U. S. government could very well come as soon as the re-election of Traitor and Terrorist Joe Biden, or upon his unexpected death before the election, the installation of the current Vice President as the President of the

U. S. A., or prior to the re-assumption of the presidency by Donald Trump, if re-elected in 2024, to the office in late January 2025

- **One more Democratically elected President could very well cement the long-awaited “silent coup” of the U. S. government and Constitution into reality**
- **This is why I am running with an imperative personal mission to abort this “silent coup,” so as to continue the so-called “Great Experiment” that is the U. S. A.**
- **We all, as American citizens, need to do all we can to assure that the U. S. A. continues to live under the U. S. Constitution with all of its rights, freedoms, and protections still in place for future generations**
- **Anything less will be a great blow and damaging loss to the world and to Planet Earth**
- **We must hold all of these primarily Hispanic and Hispanic-American Democratic Party terrorists accountable for their crimes and punish them accordingly with what they deserve—death or expatriation**
