

**ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 22**

- I'm Roy Merritt and I'm running for President of the United States in 2024.
- I'd like to say "hello" again to all of the people of the States of the U. S. A. where I have lived and worked over the years: **NY, TX, MN, IN, KY, WV, WY, AK, NH**, and **NM** twice 30 years apart (1990-96) and (2020-present).
- I welcome one and all to Terror Valley, New Mexico, located in the city and town of Las Cruces and the County of Doña Ana, in the shadows of the Vandal Mountains, on the South side of lower Dripping Trash Road. Initially dubbed by me as the "Crime Capital of the World," I now refer to this area as the "Terror Capital of the U. S. A. and World." It is here that we find a terror camp filled with criminalistic, vandalistic and terroristic "neighbors from Hell." The chief crops of this region used to be pecans and green chiles, but are now an excess or superfluity of scum and scumbags
- Terror Valley has put me and my family through over three years of terroristic, criminalistic and vandalistic acts, hate crimes, mischief crimes, and all sorts of discrimination and reprisal attacks; the denial of my Constitutional rights, freedoms, and protections. Now in my second tenure in the region, I despise the place because it is such a terrible locale in which to spend your retirement years
- Among the offenses inflicted on us are the following:
 - (a) A hospital that "waterboards" or tortures its patients;
 - (b) Specialist doctors that release patients and inform them that they are just up "Shit Creek," and refuse to even treat many Anglo patients;
 - (c) Allegedly tainted and poisoned medicines and pharmaceuticals;
 - (d) Businesses that refuse to serve Anglo customers;
 - (e) Scamming and extortion of money from Anglos;
 - (f) Adding overcharges and surcharges to goods and services;
 - (g) Restaurants that prepare contaminated, low-quality, unedible food;
 - (h) Acts of reprisal and retribution of all types, terror acts, property invasions, trespassing, property destruction and the desecration of patriotic, religious

and free speech/expression symbols like flags, crosses and xeriscape structures and features;

- (i) Threats of harm and warnings like firing off shotguns for four or more hours continuously;
- (j) Law enforcement and police officers facilitating, expediting, and seemingly directing the implementation of criminalistic, vandalistic and terroristic acts

- The Democratic Party nationwide has now morphed into the “Party of Terrorism.” Many of these Democrats are Hispanics and Hispanic Americans

- A previous speech of mine considered the issue of whether I was too radical in my views, or whether it was these Democratic Hispanic revolutionaries, traitors and terrorists who were too radical in their views


- I think I am radical in sense of supporting law and order, stiffer fines and punishments, and harsh treatment of individuals accused of repeated offenses. California, at one time, had the concept of “three strikes and you were out,” that is, you were sent back to prison for a lifetime sentence after a third strike

- I have raised the issue recently of why no one is being punished at all any more. Even children and youth are being raised as if they are special, privileged, God’s gifts to humanity, never do anything wrong and never need to be punished. Why?

- One of the questions arising today as to what is a just punishment for individuals like President Joe Biden and his son, the Governor of New Mexico, the Sheriff(s) of Doña Ana County, and others like them here in New Mexico, for example, who are traitors and terrorists to the U. S. government and Constitution, and in some cases, revolutionary *coup ‘d’étatists* as well

- My earliest campaign platform proposals included the following:

- (a) Prison farms for community criminals, vandals, and terrorists;
- (b) Hanging unelected ruling government officials for treason;
- (c) Firing all law-enforcement officers in the State of New Mexico;

- 
- (d) Trying State government officials for treason and the non-enforcement of U. S. laws and U. S. Constitution;
 - (e) Death sentences or lifetimes in prison for Joe Biden, the Governor of New Mexico, and other high-level treasonous officials;
 - (f) Deploying national-guard troops or other federal troops to southern New Mexico to protect Anglo citizens from Democratic Hispanic terrorists, traitors, and revolutionaries

- One of the questions arising today is: what is a just punishment for individuals like President Joe Biden and his son, the Governor of New Mexico, the Sheriff(s) of Doña Ana County, and others like them here in New Mexico, for example, who are traitors and terrorists to the U. S. government and Constitution, and in some cases, revolutionary *coup 'd'étatists* as well

- A related question is what do you do with individuals formerly granted citizenship to the U. S. A. but who now have turned against the country and its pre-existing citizens

- Many Democratic Hispanics are now widely perceived as revolutionaries, traitors and terrorists to the U. S. government, its Constitution, and generally to the “way of life” of the American people

- Many Hispanics have come in illegally or “invaded” the U. S. A. only for the purpose of reaping or “raping” whatever monetary benefits they can exact from the nation

- Many of these of these individuals are not only “illegal” for their original entries into the country, but also for now committing crimes, acts of revolution and terrorism against pre-existing citizens, like myself

- They are also refusing to integrate into American society, speak English, and accept the rights, freedoms, and protections granted by the U. S. Constitution. Their refusal to integrate is destroying the country

- Hispanic emigrés are the worst the nation has ever had. They include criminals, terrorists, traitors, revolutionaries, low producers, scammers and extortionists, money grubbers, mooches and sponges, leaches and parasites on American society. They want to be treated as “special” and different than other prior emigrés of various ethnicities. They desire special privileges like free medical care

and educations not even available to many poor and disadvantaged, pre-existing American citizens in the U. S. A. They seek non-competition and preferences like affirmative action in employment (e.g., as professors in U. S. colleges and universities where they take away possible positions that would go to pre-existing American citizens). They insist on speaking Spanish, being bilingual or living within a multilingual American society dependent on the use of various languages other than just the English language. Generally, all other former immigrants have not held so insistently to maintaining their own languages, customs, and ways of life

- Many Democratic Hispanic revolutionaries, traitors and terrorists not only insist and demand that their original entry be considered legal and acceptable, but they also seek the privilege of constantly trespassing on the properties of other American citizens, tearing down their “no trespassing” signs, and not recognizing, understanding and respecting the concept and practicality of property rights in America

- Democratic Hispanic terrorists, traitors and revolutionaries also want the right to use whatever methods available and at their disposal to exact a living in the U. S. A. Such methods would include acts of terrorism, property crimes and vandalism, mischief crimes, hate crimes, scamming and extortion, reprisals and retributive acts, etc., etc., etc.

- There are so many unacceptable acts of all types being perpetrated by these so-called “newer citizens” to the U. S. A. against pre-existing Anglo citizens like myself that there cannot be any acceptance of the current state of existence between the two ethnicities and groups of citizens

- Also, evidently these Democratic Hispanics are under the impression that this state of affairs must continue but it does not. Citizenship status can and must, in my view, be reviewed and re-evaluated and all individuals that fall into this class, regardless of when they came into the U. S. A. must, at the very least, be expatriated or relegated to prison farms. Hangings and other capital punishments should not be ruled out for ring-leading revolutionaries, traitors and terrorists to the U. S. A.

- Tearing down and desecrating American flags and religious symbols like the crosses of other citizens repeatedly is one of the most serious acts of

revolutionary sentiment, treason, and terrorism of all the criminalistic and vandalistic acts of new (within the last 30 to 50 years, or so) Hispanic citizens from Mexico, Central and South America

- Disregarding history and refusing to recognize the validity of American territory and American property rights in the southwestern U. S. A. is also a critical ingredient to this revolutionary treason and terrorism

- I have suggested prison farms, or forced labor camps, somewhat on the model of Russian “gulags,” as a just punishment for Democratic Hispanic revolutionaries, traitors and terrorists. They would presumably remain in these prison camps until they are considered safe and reformed, so as to return to American society

- “Gulags” were forced correctional labor camps and prisons for political dissidents in the former Soviet Union. A network of such camps was maintained throughout the country

- Expatriation, in my view, should be the most often applied punishment. Since, though, in many cases the individuals’ former countries refuse to take them back, then an appropriate alternative would be something like a prison work camp (or gulag)

- Another possibility would be sentencing them to isolated confinement on islands (Devil’s Island, Survivor Island, etc.) far out in the Pacific Ocean, for example, where they can be dropped off or parachuted in to remain for the rest of their lives

- Hanging was a widely used instrument of punishment in early American history. An individual hanged is put to death by tying a rope around his or her neck and suddenly suspending the body so as to snap the neck or cause strangulation. Hanging as a punishment is somewhat different than the prior historical lynchings of individuals often innocent of crimes

- Gallows or gallow trees were a device usually consisting of two upright posts supporting a crossbeam from which a noose is suspended and used for execution by hanging until dead

- Other possible forms of execution include:

- (a) Firing squad—a method of execution in which a group of soldiers or law enforcement officers are designated to shoot a person condemned to death in the heart or chest
- (b) Gas chamber—an enclosed space where a poisonous gas is emitted to kill the person(s) inside
- (c) Electric chair— a device used in the electrocution of a person condemned to death, consisting of a chair in which a person is restrained and a means of applying a lethal electrical current to the body
- (d) Euthanasia—act or practice of ending the life of a person (or animal) having a terminal illness or a medical condition that causes suffering perceived as incompatible with an acceptable quality of life, the suspension of certain medical treatments, or as applied by lethal injection
- (e) Lethal injection—a method of capital punishment in which a lethal substance is injected into the person sentenced to death

- Another question arises today for the first time in at least recent history whether certain so-called “cruel and unusual punishments” should be brought back into active use for revolutionary *coup d’ étatists*, terrorists and traitors to the U. S. government and Constitution. The Eighth Amendment now precludes the infliction of cruel and unusual punishment, and the imposition of excessive fines and bails

- In America’s Revolutionary Period, there were certain punishments—practices of “mob law” that are now considered “cruel and unusual”

- (a) These include stocks, a former instrument of punishment consisting of a heavy wooden frame with holes for confining an offender’s hands and feet
- (b) Pillory posts were devices with holes for the head and feet, in which petty offenders were firmly locked and exposed to public scorn, ridicule and abuse
- (c) Tarring and feathering involved pouring heated tar over a person and then covering him or her with feathers. Sometimes then, they were tied firmly to a horse and ran out of town
- (d) Lynching, or the application of so-called “lynch law” involved killing an accused person by mob action and without lawful trials, as by hanging, usually in defiance of local authority. “Lynch law” was originally named

after Colonel Charles Lynch, a Virginia magistrate who lived from 1736-96, and who “lynched” Loyalists by this means during the American Revolution. Perhaps the Loyalists needed to be “lynched,” but an argument can and should be made that maybe no one needed to be “lynched” during the Civil War and Slavery period of American history

(e) The rack was an instrument of torture consisting of a large, open wooden frame, within which the victim was laid on his back, with his wrists and ankles fastened by cords to two rollers at the ends of the frames. The rollers are drawn and moved in opposite directions until the limbs of the victim are forced from their sockets. The phrase “to put on the rack” generically means “to torture”


(f) Torture is the infliction of severe pain of any kind to force information, confess, get revenge, etc.

- The use of so-called waterboarding, or its possible equivalent, in the recent past to interrogate Middle-Eastern terrorists, is another such example. In this interrogation technique, widely considered to be a form of torture in which a person is restrained, typically by being strapped to a board with the feet higher than the head, and then immersed or doused with water to the point of suffocation or drowning

- In ancient Greece, poison hemlock was used to execute criminals. A famous example of course was Socrates, who was convicted, resisted all efforts to save his life, and willingly drank the cup of poison hemlock given to him. Of course, one could argue that if it was good enough for Socrates, it should be good enough for revolutionary *coup d' étatists*, terrorists and traitors in New Mexico, Washington, D. C., and other areas of the U. S. A.

- Crucifixion is a form of execution in which a person is put to death by nailing or binding to a cross. Of course, Jesus was crucified or executed on Calvary. When Democratic terrorists, traitors and revolutionary *coup d' étatists* las-crucify a local Anglo American citizen, then perhaps las-crucifixion would and could be a just punishment for them for their crimes, vandalism, terror acts, etc.

- Another supposed example was the now infamous Chinese torture and means of execution, and “cruel and unusual punishment,” I would agree, involved strapping a person in a seated position to a chair with a hole in its center,



restraining him or her until a bamboo shoot grew up inside their intestines and they were killed

- Would any of these “cruel and unusual punishments” be just for Democratic Hispanic revolutionaries, traitors, and terrorists to the U. S. government, the Constitution of the U. S. A., and the U. S. people?
- On some of my bad days in my life here in Terror Valley, New Mexico, I feel that they would not only be just, but would also be appropriate
