


**ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 26**

- I'm Roy Merritt and I'm a candidate for the President of the U. S. A. in 2024
- American citizens who will be voting in the next election do not want to be put in the position where they're voting for the lesser of evils
- Typically, when you're voting for one of the individuals who have already served one term in office, the second term is usually much worse than the first
- Hopefully, this will give voters some food for thought
- Because of all the terrorism my family and I have suffered with here in New Mexico over the last three-plus years, I am putting forward some new proposals as of today to deal with this exigent situation
- Earlier this year, I defined over 20 new types of terrorism that are going on here in New Mexico but also, based on secondhand information, in isolated terror camps in communities all across our nation
- As a result, we must deal with the terrorists and we will if elected to office
- I am proposing many new very harsh penalties and punishments to deal with these new terrorists of the Democratic Party
- Most, if not all, of these terrorists in New Mexico are Spanish-speaking Hispanic Democrats who should not be in the U. S. A. period
- I am putting forward the proposal that all non-English speaking Hispanic terrorists and traitors to the U. S. A., and revolutionary *coup d' é tatists* be rounded up, expatriated, relocated to isolated islands in the Pacific Ocean and left there for the remainder of their lives, or secondarily, at least in the most serious cases, be hung by the neck until they are dead
- These terrorists are destroying the U. S. A.
- Our nation today is in deep, deep trouble

- To have our best chance, we are going to have to take some radical steps, and I do not believe either of the two major candidates are prepared or equipped to deal with this situation, or are even knowledgeable of it
 - Part of the solution is extremely harsh punishments against these Democratic Party Hispanic terrorists here in New Mexico
 - These terrorists are part of a Spanish horde of infidels who have invaded our country over the past 30-50 years
 - We have got to deal with these terrorists
 - America has NEVER had to deal with such infidels as émigrés to our country ever before
 - These Spanish-speaking Hispanic Democratic terrorists are the worst émigrés our country has ever taken in
 - They and their entire families must be expatriated in one way or another
 - A just sentence for adult terrorists would be any form of capital punishment—hanging, firing squad, gas chamber, or electric chair
 - I believe that these Hispanics are the only ethnic group that we will have to deal with in this manner
 - The group proposed for punishment may not include every Hispanic, especially elderly Hispanics who came into the country years ago under different conditions and circumstances
 - These Hispanic Democratic Party terrorists have destroyed our lives here in Las Cruces and Doña Ana County, southern New Mexico
 - My family and I live across the road from Terror Valley, a terrorist camp of these Hispanic Democratic revolutionaries and traitors to the U. S. A.
 - Las Cruces is a terrorist town and city
 - Doña Ana County is a major international terrorist organization worse than the Palestine Liberation Organization (PLO), Osama bin Laden, Adolf Hitler and Benito Mussolini
 - Doña Ana County must be put out of existence

- Because of their fostering and facilitation of terrorism, there is no hope of salvaging anything out of this organization
- Leaders, including those in law enforcement, should be fired immediately
- The County office building needs to be completely demolished
- All law enforcement in New Mexico needs to be fired with no retirement benefits whatsoever
- New Mexico State Terrorist University (NMSTU) needs to be closed down permanently
- They have been educating and training Spanish-speaking Hispanic Democratic Party terrorists and revolutionaries since at least 1990
- The State of New Mexico is the first terrorist State of the U. S. A., and the first international terrorist state in the U. S. A.
- The Governor of New Mexico and other high-level State government officials, including the Attorney General, are war criminals, terrorists, and traitors to the U. S. A., and revolutionary *coup d' states* that need to be hung by the neck until they are dead
- The President, Vice President and Attorney General of the U. S. A. are war criminals, terrorists, traitors and revolutionary *coup d' states* and they should receive the same ultimate penalty
- The U. S. A. is facing the prospect of Civil War to drive these terrorists, traitors, and revolutionaries out of the U. S. A.
- The State of New Mexico must be expelled from the Union of American States
- The 2024 election will determine whether Civil War can be avoided in the U. S. A. or not depending on the outcome
- I am now asking for the support of the American people in the upcoming election
- I will do my best to avoid a 2nd Civil War, but these terrorists of the Democratic Party have infiltrated communities all across our nation and have to be dealt with
