



**ROY D. MERRITT FOR U. S. PRESIDENT  
CAMPAIGN SPEECH # 15**

- **Hispanic terrorists of the Democratic Party are now in charge of the State of New Mexico.**
- **The State is not living under or complying with the Constitution of the U. S. of America.**
- **The laws of the U. S. A. are not being enforced at any level of government**
- **The guaranteed rights, freedoms, and protections of citizens are being denied across the board.**
- **Presumably, the President and Vice President of the U. S., and the Governor of New Mexico are intimately involved in this silent coup of the U. S. government, and will, if allowed to by the voters of this country, work to cement this overthrow of our democracy and republic form of government.**
- **This could ultimately lead to the declaration of the U. S. A. as a new Spanish empire in North America.**
- **At the very least, there could be a gradual loss of other states of our Union to this Hispanic-terrorist, Democratic Party-inspired revolutionary takeover of our government and Constitution.**
- **The State of New Mexico and I have been involved in a war for the last several years, and they are trying to destroy me as the perhaps the last standing bulwark against their revolution.**
- **As I have told you before, NMSU, now NMSTU, has been involved in educating and training revolutionaries since at least 1990. Many students at the graduate level were never corrected by anyone when they declared unequivocally that the State of New Mexico and the southwestern part of the U. S. A. were still “Mexico” and Mexican territory.**

- The silent coup and revolution have now proceeded past the breaking point and the State has effectively jumped off the proverbial cliff.
  - As a part of determining the future of the State, a decision will have to be reached as to what to do with the two main higher-level educational institutions in the State.
  - In any event, I am announcing today that I am running for the presidency of the U. S. A. in order to correct this situation.
  - I have already put forward a number of proposals to aid in correcting the current state of affairs.
  - One of the most important of these is to remove New Mexico, at least temporarily, out of Statehood—the Union of 50 States, and make it a territory of the U. S.A. again, therein losing all of the benefits of membership.
  - Also, as a condition of my election run, I am also putting forward the proposition before the voters of the U. S. A. of the possibility of a declaration of war against the State of New Mexico. In other words, my election may necessarily lead to a civil war in New Mexico in order to fix this exigency.
  - Many current citizens of New Mexico—presumably Hispanic terrorists of the Democratic Party and their supporters—may be expatriated or killed in actions ordered by me, as the newly elected President, to bring New Mexico back into the fold.
  - I believe that it is necessary to draw a line and to correct this situation now in order to avoid the faintest possibility of the complete overthrow of the U. S. government and Constitution, and the establishment of an authoritarian, dictatorial government in future years.
  - It should be understood by all that my chief concerns are the continuance of our democracy and our republic, the protection of the U. S. Constitution and its core



**tenets, the safeguarding of our original people's revolution of 1776 and its aftermath, including the Declaration of Independence, the enforcement of the laws of the U. S. A. at all levels of government, and the equal/non-discriminatory treatment of all citizens of the U. S. A.**

- I now hand this over to all of the people of the U. S. A., and especially to the voters in the 2024 election, to determine a path ahead.**
- I am uncertain if any of the other candidates have a knowledge or understanding of the current dilemma our nation faces.**
