## ROY D. MERRITT FOR U. S. PRESIDENT CAMPAIGN SPEECH # 12

- One of my proposals is to establish Citizenship Tribunals and Terror Squads in every county in the U. S. A. to evaluate the citizenship and crime/terrorism records of all new citizens who have entered the country since 1990.
- We may very well consider citizens of all ethnicities if we need to, or if a ruling is made that we can concentrate on new citizens from Mexico and the southern American countries, then we will do that.
- These newer citizens will be asked to testify on their behalf and answer a series of questions concerning their original granting of citizenship in the U. S. A. and whether they had good intentions when they originally obtained citizenship, and whether they have been able to succeed, or fail, as newer citizens to the U. S. A.
- A tribunal of perhaps 9 long-time residents and citizens of the U. S. A. prior to 1990 should be sufficient to evaluate and reach a decision concerning the citizenship status of these individuals, and whether they are to maintain their citizenship in the U. S. A. or not.
- The list of questions asked to these individuals will include such queries as the following:
- (01) Did you originally enter the U. S. A. legally?
- (02) Did you obtain your citizenship under false pretenses?
- (3) Do you consider yourself a loyal and faithful citizen of the U. S. A.?
- (04) Do you owe your primary allegiance to the U. S. A. as a country?
- (05) Do you love your new country?
- (06) Do you harbor sentiments of strong affiliation for your former country or another country besides the U. S. A.?
- (07) Do you wish to return to your home country some day?
- (08) Would you say that the primary reason you came to the U. S. A. was to earn more money for your family?
- (9) How many children do you have, and how many were born in the U. S. A. since you obtained citizenship?

- (10) Have you taken welfare checks, food stamps or other benefits from the U.
- S. A. since you obtained your citizenship?
- (11) Have you received free medical care in emergency rooms in the U. S. A.?
- (12) Have you broken any laws of the U. S. A., your State, County, or city?
- (13) Have you committed any crimes against your fellow citizens?
- (14) Have you trespassed on your neighbors' property and done damage or destruction since your arrival?
- (15) Have you issued any threats of harm to any other American citizen?
- (16) Do you support the Constitution of the U. S. A.?
- (17) Do you respect the flag of the U. S. A.? Have you trespassed and torn down a neighbor's flag or flags?
- (18) Have you defended your nation—the U. S. A.—against all enemies?
- (19) Would you fight against your former home country if you were called upon to do so?
- (20) Have you caused serious problems or difficulties in the lives of other U. S. citizens since your arrival in the U. S. A.?
- (21) Are you in the U. S. A. primarily to extract whatever financial gain you can from it?
- (22) Have you worked hard as an American citizen?
- (23) Did you receive a free education or other educational benefits from the U. S. A.?
- (24) Have you entered a profession since coming to the U. S. A.?
- (25) Do you rely solely on your religious beliefs in determining how many children you want in your family?
- (26) Do you think it's o.k. to have as many children as you want in consideration of the existent realities of life in the U. S. A. and on Planet Earth?
- (27) Would you say a family of 10 children or more would be acceptable to have in today's world?
- (28) Do you believe you represent a danger to the U. S. A. in any way?
- (29) Do you strongly support the democracy and republic form of government in the U. S. A.?
- (30) Do you support the Democratic Party above all others?
- (31) Do you feel that you should be given special rights over other citizens of the U. S. A.?

- (32) Should you be given preferential treatment of any kind over other poor or deprived people of the U. S. A.?
- (33) Have you charged anyone, including an officer of the law, with discrimination since coming to the U. S. A.?
- (34) Have you received large income tax checks from the U. S. A. since your arrival in the country?
- (35) Do you believe that you are a burden on the societal systems of the U. S. A.?
- (36) Do you believe that it is o.k. to enter the U. S. A. illegally?
- (37) Have you upheld all the requirements of citizenship since obtaining it in the U. S. A.?
- (38) Do you speak English as your primary language?
- (39) Do you believe it is o.k. to speak Spanish in public to another American citizen who may or may not know Spanish?
- (40) Can you recite the Pledge of Allegiance? Do you believe in the Pledge of Allegiance to the U. S. A.?
- (41) Have you worked hard to become a good citizen of the U. S. A.?
- (42) Have you become disenchanted in any way with your new country?
- (43) Do you favor aspects of your ways of life and living in your previous country over the U. S. A.?
- (44) Do you believe you have committed any acts of terrorism against your fellow citizens or the U. S. A. since entering the country?
- (45) Do you believe you harbor any revolutionary sentiments against your new home country?
- (46) Do you support the overthrow of the U. S. government?
- (47) Would you consider supporting any other political party other than the Democratic Party in the U. S. A.?
- (48) Do you place a high value on the guaranteed freedoms, rights, and protections afforded to you by the U. S. Constitution?
- (49) If you were told that you are <u>NOT</u> being afforded these freedoms, rights, and protections, would it make a difference to you or do you care?
- (50) Do you believe the U. S. A. to be a special nation based on its' founding, history, traditions, etc.?
