

**ROY D. MERRITT FOR U. S. PRESIDENT  
CAMPAIGN SPEECH # 4**

- Of all the States of the U.S. A. that I have lived and worked in during my lifetime, including AK, IN, KY, MN, NH, NM, NY, TX, WV & WY, the only one where I have felt that I have been denied my rights guaranteed by the U. S. Constitution is New Mexico.
- State, county, city, subdivision or any other smaller governmental unit CANNOT deny a citizen his (or her) rights guaranteed by the U. S. Constitution.
- The Bill of Rights, contained in the first ten amendments to the U. S. Constitution, GUARANTEE every American citizen Constitutional freedoms.
- These cannot be denied or abridged by any lord or overlord, no matter who or whom they are!
- The Bill of Rights is **ABSOLUTE!** The rights guaranteed therein cannot be prohibited by anyone.
- These rights cannot be restricted, limited, diminished, reduced, condensed, curtailed, deprived or taken away.
- The Preamble to the U. S. Constitution was written for a number of reasons which are clearly stated:
  - (1) To form a more perfect Union;
  - (2) To establish justice;
  - (3) Insure domestic tranquility;
  - (4) Provide for the common defense;
  - (5) Promote the general welfare; and
  - (6) Secure the blessings of liberty
- In my second stay here in the State of New Mexico, I have not found any of these for myself:

*“There is no unity; there is no justice; there is no tranquility; there is no protection or defense; there is no welfare; and there certainly is no LIBERTY, or the blessings thereof.”*
- I am not FREE!
- ARTICLE I of the Bill of Rights states that Congress (or understood, no other governmental unit of the U. S. A.) will make a law respecting an establishment of RELIGION, or prohibiting the free exercise thereof; or abridge the freedom of speech or of the press; or the right of the people to peaceably assemble; or to petition the government for a redress of grievances.
- This is what I am now asking the governments of the U. S. A. to do.

- I have obviously developed many grievances since living here in the State of New Mexico for the second time.
- I have found that I do not have free speech, or as incorporated therein I believe, free expression and the practice thereof, and free press—or the ability to write and publish on the “town square” what I believe.
- I certainly have not had freedom of religion, as I believe and practice it.
- I have not found the freedom to express my patriotism or love of country, and this right in my opinion, also involves my freedom of religion.
- I have not found the freedom to peaceably assemble, or as I believe is herein incorporated, NOT to assemble. No one can be forced to assemble (or, associate) if they do not believe in a principle, cause or action.
- That is, I can either associate or NOT! That is why the Freedom of Association, as I state it, is inherent, understood, and manifest.
- There are now living under these protections and freedoms, in the governmental units of the State of New Mexico (especially the County of Doña Ana, the city of Las Cruces, and the subdivision of “Lake Lucero” ) those who do not understand them.
- I have been denied for over three years my freedoms guaranteed by the U. S. Congress. This is why, without redress, I will be forced to sue in federal court, and to pursue to the U. S. Supreme Court, if necessary, to seek a remedy and proper amends, in the form of monetary compensation, for these denials.
- This is why I have also been forced to run for the presidency of the U. S. A. in 2024.
- I have had all sorts of crimes and punishments levied against me for over three years by the subdivision, city, County and State of New Mexico for my beliefs.
- I do not believe that I can immediately come up with a complete list of these crimes and punishments.
- I have lost my peace of mind, my health, my happiness and contentment, my general feeling of personal welfare, my leisure in retirement and lack of need to labor intensively, and my pursuit of artistic and literary goals at least, in the manner that I want to pursue them, by these actions of governmental units of the U. S. A.
- But certainly among these crimes and punishments, as I see them, are:

- (1) Vandalism and all sorts of vandalistic actions against me and my property;**
- (2) Scamming, extortion, and the exaction of higher prices for goods and services;**
- (3) Trespassing, and the tearing down and removal of my “no trespassing” signs;**
- (4) Property destruction;**
- (5) Property desecration, including destroying artistic, sculptural and religious symbols of free speech and expression;**
- (6) Property trashing and environmental terrorism;**
- (7) General rights of property ownership and the benefits thereof;**
- (8) Hate crimes;**
- (9) Mischief crimes;**
- (10) Discrimination;**
- (11) Loss of personal privacy and free communication**
- (12) Retributive, wrongful, and unlawful actions of all types**
- (13) And, as I say, ETC., ETC., and ETC.!**

- **These circumstances are obviously a place in which I did not want to find my family and myself.**
- **I initially only wanted to retire here to New Mexico in peace and happiness, but these I, nor we, have been able to find, unfortunately.**
- **Therefore, I am immediately in need of a seasoned person, living nationwide, who will assist me in pursuing these goals and actions. I do not believe that I can accomplish them alone and will need the help of others.**
- **But, I will continue to fight them alone, and for as long as I have to, if I must.**
