

**ROY D. MERRITT FOR U. S. PRESIDENT
CAMPAIGN SPEECH # 20**


- I'm Roy Merritt and I'm running for President of the United States in 2024.
- I'd like to say "hello" again to all of the people of the States pf the U. S. A. where I have lived and worked over the years: **NY, TX, MN, IN, KY, WV, WY, AK, NH,** and **NM** twice 30 years apart (1990-96) and (2020-present).
- It is obvious to me that many people, perhaps most people, at large in the community, the city, the County, the State, and across our great country feel that I am lying or greatly exaggerating when I tell them about what has been happening to me and my family here in New Mexico over the past three-plus years
- I know that I, too, have often wondered why the people of Terror Valley don't stop what they're doing, and why they haven't stopped doing what they have been doing over these past several years
- Of course, I am referring here to the terroristic, criminal, and vandalistic acts, the hate crimes, mischief crimes, the flag destruction and desecration, the discrimination, the scamming and extortion, etc., etc., etc.
- From my perspective, these people are either terrorists themselves and part of the grand plot—the "Grand Conspiracy"—or they have been directed by others—the terrorist leaders, lords/overlords, police and/or law enforcement, and/or government leaders locally, Statewide, and/or nationally—to continue what they have been doing to me and to others
- These people—call them "terrorists" if you will—because they are terrorists—whether they are implementing these acts of terror either wittingly or unwittingly
- Regardless, it is crystal clear to me That "THEY ARE NOT GOING TO STOP THE TERRORISM AND TERROR ACTS UNLESS THEY ARE FORCED TO DO SO."
- They will have to be expelled from the U. S. A., expatriated by force, for example, as by the "Terror Squads," which I have proposed, or by some other

violent removal process, or have a death sentence carried out by government leaders in positions of authority to do so

- They could also be sentenced to expulsion/expatriation by the “Citizenship Tribunals,” which I have proposed, but that will take a lot of time to carry out
- In any case, these “terrorists” may very well be dupes to the overall plot, the “Grand Conspiracy” to overthrow the government of the U. S. A.
- Their terror acts and terrorism, though, are a matter of course—perfected practice—based on the roles they are playing
- They know exactly what they are doing because they have performed their roles over, and over, and over, and over
- The criminal, vandalistic and terroristic acts they are perpetrating are of the highest order and can be looked at as part of a “tragic opera”
- They have performed these same terror acts on many others before—likely, people like me—long-time returning retirees to this community
- I do not believe that the general public and citizenry are supposed to notice that the State of New Mexico has left the Union of States, or to notice that police are not enforcing the laws of our State or nation
- These local terrorists are going beyond to implement their practiced roles in these terror acts
- A part of this I believe is destroying individuals’ health and lives on purpose
- I also think that there are many other people of the community who know what is going on, but they are “threatened” and are afraid to come forward
- In prior speeches, I have asked the people of Terror Valley why they keep doubling down on their acts of terrorism
- The short answer to this is that they have nothing to fear
- Democratic terrorist leaders and participating government officials continue to play their same roles and carry out the same acts day after day, week after week, month after month, and year after year

- They know that their ultimate goal is, in the end, the overthrow of the U. S. government, democracy, republic, and Constitution
- The players in the tragic opera—the “Grand Conspiracy”—if you will, know exactly what they are doing and what they have been working on perhaps for decades
- They have been striving to put the right people in the right positions to complete the “play” and bring it to the ultimate desired completion—the overthrow of the U. S. government
- Individuals like myself are just pawns—preferably dupes—to their ultimate goals
- I know that, at least for myself, I am not in a position where I can alone stop them from achieving their ultimate goals. I will need help!!!
- The destruction of the people who stand in their way—people like me and perhaps Donald Trump—are just a part of the tragic opera that is unfolding
- I believe that these same people have been trying to destroy Donald Trump as well
- Perhaps the Democratic Attorney General of Georgia is another player in this tragic opera
- President Joe Biden is too, but he may be actually totally unaware that he is an actor performing in this same opera that ends with the overthrow of the U. S. government, the installation of the Vice President of the U. S. A., or yet another unidentified person to me, Donald Trump, or the American people
- Some individuals, though, like myself, and perhaps Donald Trump, are in vulnerable positions, because we are major threats to the completion of the plot—the “Grand Conspiracy”—to its ultimate climax with the installation of an authoritarian dictatorial leader as the new head of the American government
- It is unclear whether others on the national scene know that this tragic opera is now being played out
- Donald Trump, and other presidential candidates, may be completely unaware that such a tragic opera is, or may very well be, unfolding at this time

- In my case, returning here after some 30 years away, it could be that I was supposed, perhaps by God's plan, to be here at this time and place
- I could very well be one of only a few who could and would work against the implementation of the plot to its ultimate final conclusion
- I would say that a lot of this has only been clarifying to me in my mind piecemeal, and so too, I might also be unaware of some of the ultimate ends of the conspirators and terrorists to the U. S. government
- For example, I may not know or realize how widespread the conspiratorial plot is, how many players there are, how many States of the U. S. A. are involved, who many of the key actors are, and a full understanding of the roll-out stages and exact timing of the related events
- I think that a lot of this I have "guessed" at based on the specific actions of some of the local players involved in the plot over the last several years here in New Mexico
- Other unknowns relating to who the key players in this tragic opera are, and that require definitive corroborations of their specific involvement are:
 - (1) the President and Vice President of the U. S. A., for example;
 - (2) the Governor of New Mexico and other State leaders;
 - (3) the State of New Mexico and federal attorney generals;
 - (4) the Sheriff, deputies, and other leaders of Doña Ana County, New Mexico;
 - (5) law enforcement and police at least in New Mexico and perhaps other States;
 - (6) unelected rich people—lords and overlords—here in Las Cruces and Doña Ana County;
- There are many questions related to the plot and conspiracy that are yet unanswered
- For example, is the ultimate goal the establishment of a Spanish/Hispanic-led government in the U. S. A.?
- What are the exact desirable ends of the plotters and overthrowers?
- Is it the establishment of a Spanish-speaking or bilingual nation?

- Is it the phase-out of the U. S. Constitution?
 - Will they initially declare a stage of martial law?
 - What is the role, if any, of the U. S. military branches in the overthrow? Who are the key military leaders, if any, involved in the plot?
 - What is, and has been, the role of universities, like NMSU and the University of New Mexico?
 - How long exactly has the plot been in play—in roll-out? Could I have guessed right in saying that it has been at least since 1990? Or, was the long-term goal decided many, many years ago?
 - What can be done to stop the implementation at this plot, if anything?
 - Have I perhaps guessed correctly again that only Donald Trump, and/or myself may stand in the way of the ultimate fruition of the plot?
 - Has the gradual non-enforcement of the laws of the federal and State governments, as here in Doña Ana County, New Mexico, been a part of the long-term roll-out?
 - Is President Joe Biden a key player or a dupe to the conspiracy?
 - Are other States and perhaps other Hispanic leaders at the National level involved in the plot?
 - Exactly, how wide-ranging is the plot?
 - Are other nations, and/or international leaders involved?
 - Is the complete destruction of the so-called “Great American Experiment” and its ideals a key goal in the plot?
 - And what about the denial of the rights, freedoms, and protections of the U. S. Constitution to the American people?
 - Has the Democratic Party on the national scene been a part of it from the start?
 - As, for example, with their “open-doors” policy and other pro-Hispanic policies of the party that go back many decades? And, also, the mass immigrations, or

“invasions” of Hispanic Democratic voters from Mexico and other southern American countries?

- **Has the national media been playing a role in the plot, or has it just been an unwitting aider and abettor to the plot?**
- **These are questions that I believe we can and must ask (and answer) as a part of the election for the presidency of the U. S. A. in 2024**
- **I am running myself because I have essentially been “forced” to do so by my atrocious treatment over the past three-plus years by the terrorists of Terror Valley, New Mexico**
- **By the actions and inactions of law enforcement and government leaders at all levels—city, County, State, and federal**
- **By the denial of my Constitutional rights and freedoms: freedom of speech and expression; freedom of religion; freedom of press and publication; and freedom of association**
- **By all the terroristic, criminal, and vandalistic acts, discrimination, hate crimes, scamming and extortion, etc., directed at my family and me since my return to the State of New Mexico in early 2020**
- **I have not been able to find any other viable answers to such inexplicable acts and treatment**
- **I hope that the American people at large will help me answer these questions in the election year of 2024**
